ORDINANCE FOR LONG TERM PUBLIC WAY EASEMENT

WHEREAS, The City of Chicago ("City") is a home rule unit of government by virtue of the provisions of the Constitution of the State of Illinois of 1970 and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant a long term public way easement for an existing loading dock tunnel under the public street ("Fullerton Avenue") described in the following ordinance; now therefore,

WHEREAS, 710 West Fullerton Avenue, LLC, a Delaware limited liability company, licensed to transact business in Illinois ("Grantee") is the owner of the properties commonly identified as 700-712 W. Fullerton Avenue (the "Grantee Property"); and

WHEREAS, Grantee owns an existing, below grade tunnel (the "Grantee Tunnel") connecting the Grantee's Property on the north side of W. Fullerton Avenue, to certain properties located at 701-739 West Fullerton Avenue ("REIT Properties") owned by the Lincoln Fullerton REIT Property LLC, a Delaware limited liability company, licensed to transact business in Illinois (the "REIT") on the south side of W. Fullerton Avenue; and

WHEREAS, the Grantee Property and the REIT Properties collectively shall be referred to herein as the "Properties"; and

WHEREAS, the Grantee Tunnel is utilized and continues to be used for the purpose of transporting deliveries; conducting move in/move out operations from the loading dock located at South Fullerton Avenue; and pedestrian access associated with the Properties; and

WHEREAS, REIT has received the benefit of use of the Grantee Tunnel and further has consented to connection of the Tunnel between the Properties; and

WHEREAS, the Grantee Tunnel was previously permitted under the Use of the Public Way Program ("Program") by the City's Department of Business Affairs and Consumer Protection ("BACP"), however the Pedestrian Tunnel is no longer being handled under that BACP Program; and

WHEREAS, Grantee represents it has expended substantial funds for the construction of the Grantee Tunnel in order to facilitate the interconnection between the Properties; and

WHEREAS, Grantee has requested that the City grant it a long term public way easement to accommodate the Grantee Tunnel under Fullerton Avenue; and

WHEREAS, the Grantee Tunnel will require the use of the public right-of-way, specifically limited rights below the grade of Fullerton Avenue ("Public Way Easement

Area"), as depicted and legally described on the Plat of Easement ("Plat") attached hereto and make a part hereof as Exhibit A; and

WHEREAS, the City's Department of Transportation ("CDOT") has determined that the Grantee Tunnel will not interfere with the City's traffic infrastructure and will benefit the local surrounding businesses adjacent to and connecting to the Grantee Tunnel; and

WHEREAS, the City is willing to grant the Grantee a long term public way easement to accommodate the Grantee Tunnel under Fullerton Avenue on the same terms and conditions set forth in the Public Way Easement Agreement (the "Public Way Easement Agreement") attached hereto and incorporated herein as Exhibit B; now, therefore,

Be it Ordained by the City Council of the City of Chicago;

SECTION 1. The foregoing recitals are hereby incorporated herein and adopted as the findings of the City Council.

SECTION 2. The Commissioner of the Department of Transportation (the "Commissioner"), or any designee of the Commissioner, is each hereby authorized, along with the approval of the City's Corporation Counsel as to form and legality, to execute and deliver the Public Way Easement Agreement between Grantee and the City, substantially in the form attached thereto as Exhibit B and made a part hereof, and such other supporting documents as may be necessary or appropriate to carry out and comply with the provisions of the Public Way Easement Agreement.

SECTION 3. The Public Way Easement Area, as set forth in the Public Way Easement Agreement, shall be subject to, and the Grantee accepts, an existing Water Department 12" main, 36" brick sewer and other and appurtenances that may encroach into the Public Way Easement Area as described on the Plat, Exhibit A. It is further provided that the City shall have 24 hour access to the Public Way Easement Area, and that no new private structures shall be erected or other use made of the Public Way Easement Area, which in the judgment of the municipal officials having control of the aforesaid service facilities would interfere with the use, maintenance, renewal, or reconstruction of said facilities, or the construction of additional municipally-owned service facilities. It is further provided that any repair or replacement of private property damaged in the Public Way Easement Area as a result of the City exercising its access rights shall be the responsibility of the Grantee, its successors or assigns. In the event that the Grantee wishes to modify or install new facilities in or connecting to the Grantee Tunnel, plans must be reviewed, approved and permitted by CDOT and the City's Department of Water Management ("DWM") prior to the commencement of any work, with as-built drawings submitted to DWM within 45 days of completion.

SECTION 4. The Public Way Easement Area, as set forth in the Public Way Easement Agreement, shall be subject to, and the Grantee accepts, existing Commonwealth Edison facilities that may encroach into the Public Way Easement Area. Commonwealth Edison, its successors or assigns, shall have 24 hour access, with no new private structures being erected upon, or other use made of the Public Way

Easement Agreement Area, which in the judgment of said utility officials having control of the aforesaid service facilities would interfere with the use, maintenance, renewal, or reconstruction of said facilities, or the construction of additional service facilities. It is further provided that any repair or replacement of Developer property damaged in the Public Way Easement Area as a result of Commonwealth Edison exercising its access rights shall be the responsibility of the Grantee, its successors or assigns. In the event that the Grantee wishes to renovate, modify or install new facilities in the Public Way Easement Area, plans shall be reviewed and approved by the utility prior to commencement of any work.

SECTION 5. If any provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this ordinance.

SECTION 6. The Public Way Easement Agreement herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Grantee shall pay or cause to be paid to the City of Chicago as compensation for the benefits which will accrue to the Grantee of the property said part of the public street for which the easement is being granted the sum of _____ dollars (\$ _____), which sum in the judgment of this body will be equal to such benefits.

SECTION 7. The Public Way Easement Agreement herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, Grantee shall file or cause to be filed for recording in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, the fully executed Public Way Easement Agreement, and the accompanying Plat of Easement, **Exhibit A**, as approved by the Department of Transportation's Acting Superintendent of Maps and Plats.


SECTION 8. The Public Way Easement Agreement shall take effect upon recording of the ordinance, Public Way Easement Agreement, and approved Plat of Easement.




PLAT OF EASEMENT



Public Way Easement Agreement
(Grantee Tunnel)

This Agreement (the "Agreement") is entered into as of this ____ day of ____ 2017, by and between the City of Chicago, an Illinois home rule municipal corporation, by and through its Department of Transportation (the "City") and 710 West Fullerton Avenue, LLC, a Delaware limited liability company, licensed to transact business in Illinois ("Grantee"). City and Grantee together shall be referred to herein from time to time as the "Parties", and individually as a "Party".

Witnesseth:

WHEREAS, Grantee is the owner of real property commonly known as 700-712 W. Fullerton Avenue, Chicago, Illinois, as legally described on **Exhibit A** attached hereto and made a part hereof (the "Grantee Property"); and

WHEREAS, Grantee intends to improve the Grantee Property with a senior housing facility and related improvements (collectively, the "Building"); and

WHEREAS, certain properties located at 701-739 West Fullerton Avenue (the "REIT Properties") are owned by Lincoln Fullerton REIT Property LLC, a Delaware limited liability company licensed to transact business in Illinois (the "REIT") on the south side of W. Fullerton Avenue; and

WHEREAS, the Grantee Property and the REIT Properties collectively shall be referred to herein as the "Properties"; and

WHEREAS, the Grantee owns certain portions of an existing, below grade tunnel (the "Grantee Tunnel") connecting the Grantee's Property on the north side of W. Fullerton Avenue, to the REIT Properties; and

WHEREAS, the Grantee Tunnel was historically used for the purpose of transporting deliveries and facilitating pedestrian access between the Properties; and

WHEREAS, REIT has received the benefit of use of the Grantee Tunnel and further has consented to connection of the Grantee Tunnel between the Properties; and

WHEREAS, Grantee previously held a City permit, issued by the City Department of Business Affairs and Consumer Protection, for the Grantee Tunnel to connect the Properties under the City's public right-of-way, namely Fullerton Avenue ("Street"), said Grantee Tunnel being eight hundred twenty seven (827) square feet more or less ("Public Way Easement Area"), as more fully described on the Plat of Easement ("Plat") attached hereto as **Exhibit B**; and

WHEREAS, the Grantee Tunnel will continue to require the below grade use of Street, as more fully depicted on the Plat; and

WHEREAS, Grantee proposes to use the Grantee Tunnel for the purposes of facilitating pedestrian access for guests and invitees of the Properties; transporting deliveries of supplies from the Fullerton Avenue Loading Dock (the "Loading Dock"); conducting move in/move out operations from the Loading Dock; and other necessary functions related to Grantee's intended use of the Building as a senior housing facility.

NOW, THEREFORE, in consideration of the above preambles, the mutual covenants herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

Grant of Easement Area. The City hereby grants to Grantee a public way easement ("Easement") to use and occupy, in accordance with this Agreement, those certain limited below grade rights in the Street and the Public Way Easement Area, as identified and legally described on the Plat, for the existing and ongoing use, operation, maintenance, repair and replacement of the Grantee Tunnel. The Parties hereto may, upon review and approval of the Commissioner ("Commissioner") of the Department of Transportation, or any successor department ("CDOT"), substitute, subject to review and approval of the City's Corporation Counsel, a revised Public Way Easement Area legal description for the Public Way Easement Area, as set forth on **Exhibit C** attached hereto and made a part hereof.

1. **Terms.** The following terms and conditions apply to the Easement:

- (a) The Easement is an easement appurtenant in favor of Grantee.
- (b) The Easement is granted for a term of twenty (20) years ("Term") provided that the Grantee pay compensation to the City in the amount described in the ordinance adopted by the City Council of the City of Chicago on _____, 2017 ("Easement Ordinance") approving the Easement and this Agreement.
- (c) The Easement shall burden the Public Way Easement Area as the servient tenement.
- (d) Grantee warrants to the City that it is the owner of the adjacent Grantee Property, is owner of the existing Grantee Tunnel structure, and that the Grantee has sufficient title and fee interest to/in the Grantee Property to enter into this Agreement.

(e) The public way Easement granted pursuant to this Agreement constitutes a contemporaneous grant of interest in real property and is not executory in nature.

(f) Grantee shall not transfer any interest in the Easement without the prior written consent by the Commissioner of CDOT, provided that the foregoing shall not be construed to prohibit Grantee from assigning a collateral security interest in the Grantee Property or the Easement in the ordinary course of Grantee's business and operations. In the event of a change in the Grantee's status, or Grantee transfers any interest in the Easement, the Easement will immediately terminate and the new owner of the Grantee Property must apply for an easement or promptly remove the Tunnel at the new owner's sole cost and expense

2. Grantee's Obligations.

(a) The Grantee represents that, to the best of its knowledge, the Grantee Tunnel is in compliance with all federal, state and local laws and regulations. The Grantee further expressly warrants that the Tunnel is in compliance with accessibility standards, including, but not limited to: (1) the Americans with Disabilities Act of 1990, 42 U.S.C. 12101, et seq., and the regulations promulgated thereunder; (2) the Illinois Environmental Barriers Act (410 ILCS 25/ 1 et seq. (1996)); (3) The Illinois Accessibility Code, 71 Ill. A. Code 400; (4) all local City ordinances, codes, regulations.

(b) The Grantee shall be responsible for obtaining ongoing approvals of and payment for any and all removals, relocations, alterations, additional maintenance and restorations of or to any utility or public service structures or facilities, or any structures or facilities located in or adjacent to the Public Way Easement Area which are owned by the City, including pavements, bridges, poles, and other facilities and utilities, which are or may be necessary or appropriate to facilitate work related to the Grantee Tunnel. The Grantee shall be responsible for obtaining the consent of and making suitable arrangements with all entities owning and having an interest in such structures and facilities, including any City department.

(d) The Grantee shall secure all necessary permits, including but not limited to, building permits, required under applicable law.

3. Uses Within the Easement Area.

a) Intentionally Deleted. for

b) The Grantee may not authorize the Grantee Tunnel for any purpose other than for the purpose of transporting deliveries; conducting move in/move out operations from the Loading Dock; facilitating pedestrian access associated with the Properties; and such other uses necessary or incidental to the operation of the Building as a senior housing facility.

c) The Grantee may utilize the Grantee Tunnel for exhibits, displays and the like that shall not substantially interfere with the public's use described in this Agreement.

d) Grantee may establish reasonable rules and regulations related to the use of the Grantee Tunnel. Grantee may at its sole discretion control the use of and access to the Properties through the Grantee Tunnel. Notwithstanding the foregoing, the City

reserves a right to daily 24 hour access to the Grantee Tunnel and Public Way Easement Area for City business purposes and services available to all similarly situated improvements upon reasonable prior notice to Grantee.

4. Grantee Tunnel Alterations.

Grantee may from time to time replace, remodel or demolish all or any portion of the Grantee Tunnel so long as the Grantee secures the prior written approval of the Commissioner (or any successor department's Commissioner) and City Council for alterations that may affect the Public Way Easement Area, other portions of the public right-of-way, or an existing Water Department 12" main, 36" brick sewer and other and appurtenances that may encroach into the Public Way Easement Area as described on the Plat, **Exhibit B**, before making any alterations to the Grantee Tunnel that would change the description provided on the Plat.

5. Intentionally Deleted.

6. Removal and Restoration. Grantee shall have the right to terminate this Easement at any time. Upon termination of the Easement granted by this Agreement the Grantee and upon written request of the City, without cost or expense to the City, shall promptly remove the Grantee Tunnel, and all other structures and facilities related to the Grantee Tunnel as may be located in the Public Way Easement Area and other affected public way. Grantee shall restore the public way to the extent altered, disturbed, or damaged by the installation, construction, use, operation, inspection, maintenance, repair, replacement or removal of the Grantee Tunnel, and all work related thereto, to a proper condition under the supervision and to the satisfaction of the Commissioner and in accordance with the Municipal Code of Chicago.

7. Indemnity. Except with respect to the negligent or wrongful intentional acts of City (to the extent the same are the cause of an injury or loss to a third person), Grantee hereby indemnifies and agrees to hold harmless and defend City from and against any and all claims, demands, damages, lawsuits, legal proceedings, losses, liens, liabilities, judgments, orders or decrees, and all reasonable costs and expenses (including, without limitation, reasonable attorneys' fees, court costs, and other reasonable expenses related to litigation), arising from or as a result of the death of, or any accident, injury, loss or damage whatsoever caused to the City, any natural person, or the City's property, including but not limited to the Public Way Easement Area and all other impacted City right-of-way, the property of any person, arising out of, or occurring in any manner relating to the Public Way Easement Area, or the Grantee Tunnel. In the event any legal action is taken against City or its agents or any claim is made relating to the Public Way Easement Area or the Grantee Tunnel, the City may elect to tender said defense to Grantee which shall and must defend such action or claim at Grantee's own expense and City shall cooperate with Grantee in the defense thereof. City shall have the right to join Grantee as a party defendant in any such legal action. This indemnity shall not be the exclusive remedy of the City, and City shall maintain whatever other right of indemnity it may have under common law, by statute, or by ordinance.

8. Grantee's Operation, Maintenance and Security of the Public Way Easement Area and Grantee Tunnel during the Term of this Agreement.

(a) Grantee shall maintain the Public Way Easement Area and Grantee Tunnel at its sole cost and expense.

(b) Grantee shall maintain the Public Way Easement Area and Grantee Tunnel so that the improvement does not unduly interfere with any use of the public way by the City, the public, or any person or entity authorized to use or occupy the public way.

(c) Grantee shall conduct regular, documented inspections of the Grantee Tunnel and the Public Way Easement Area and maintain the Grantee Tunnel and Public Way Easement Area in a structurally sound, clean, aesthetically attractive, and usable condition consistent with the public use required by this Agreement. All Grantee Tunnel and Public Way Easement Area maintenance records shall be made available to CDOT upon CDOT's written request for such documentation to Grantee.

(d) Grantee shall attach no fixtures, post no verbiage, signage, symbols, art or advertising of any kind on the interior of the structure, other than the name of Grantee in fixed letters no larger than one sixth of the functional height of the structure as permitted under a compensated Use of the Public Way permit submitted to the Department of Business Affairs & Consumer Protection, or its successor department. The Grantee shall not lease nor enter into any agreement for the Grantee Tunnel or Public Way Easement Area lying over, under, on or in the public way for advertising space purposes, or for any other promotional use(s) for the Grantee or any third parties.

(e) Grantee shall cooperate with the City concerning the coordination of uses of the public way, including prompt responses to inquiries, attending meetings and site visits, and providing complete disclosure of information concerning the Public Way Easement Area and Grantee Tunnel.

(f) Grantee shall pay for any and all utility expenses incurred with respect to the operation, maintenance, repair, replacement, and/or removal of the Grantee Tunnel, or any part thereof, within the Public Way Easement Area.

(g) Grantee shall provide security over the Public Way Easement Area and Grantee Tunnel at its sole cost and expense.

9. City Has No Maintenance and Operational Duties. The Grantee acknowledges that City is not responsible for the operation, maintenance, repair, replacement, and/or removal of or security of the Public Way Easement Area and the Grantee Tunnel, and City has no obligations with respect thereto (other than the provision, through the exercise of the City's right to access the Grantee Tunnel and Public Way Easement Area for City business purposes and services available to all similarly situated improvements).

10. Insurance.

(a) The Grantee shall procure and maintain, at all times, or shall cause to be procured and maintained, all of the types and coverages of insurance specified below, with

insurance companies authorized to do business in the State of Illinois, covering all operations under this Agreement, whether performed by the Grantee or any of its contractors.

(b) The kinds and amounts of insurance required are as follows:

(i) Workers' Compensation and Occupational Disease Insurance.

Workers' Compensation and Occupational Disease Insurance, in statutory amounts, covering all employees who are to provide Work under this Agreement. Employers' liability coverage with limits of not less than One Million Dollars (\$1,000,000) each accident, illness or disease.

(ii) Commercial Liability Insurance (Primary and Umbrella).

Commercial General Liability Insurance, or equivalent, with limits of not less than Five Million Dollars (\$5,000,000) per occurrence for bodily injury, personal injury, and property damage liability. All premises and operations, products/completed operations, independent contractors, explosion, collapse, underground, separation of insureds, defense and contractual liability coverages are to be included. The City is to be named as an additional insured on a primary non-contributory basis for any liability related directly or indirectly to this Agreement.

Contractors performing work for Grantee must maintain limits of not less than \$2,000,000 with the same terms herein.

(iii) Automobile Liability Insurance. (Primary and Umbrella)

When any motor vehicles (owned, non-owned and hired) are used in connection with work to be performed, the Grantee provide or cause to be provided, Automobile Liability Insurance with limits of not less than Two Million Dollars (\$2,000,000) per occurrence for bodily injury and property damage. The City is to be named as an additional insured on a primary, non-contributory basis.

Contractor performing work for Grantee must maintain limits of not less than \$1,000,000 with the same terms herein.

(c) Additional Requirements

The Grantee must provide and cause any of its contractors to provide the City of Chicago, Department of Transportation, 30 North LaSalle Street, Room 500, Chicago, Illinois 60602-2570, original Certificates of Insurance, to be in force on the date of this Agreement, and Renewal Certificates of Insurance, or such similar evidence, if the coverages have an expiration or renewal date occurring during the term of this Agreement. The receipt of any certificate does not constitute agreement by the City that the insurance requirements in the Agreement have been fully met or that the insurance policies indicated on the certificate are in compliance with all Agreement requirements. The failure of the City to obtain certificates or other insurance evidence from Grantee and contractor is not a waiver by the City of any requirements for the Grantee to obtain and maintain the specified coverages. The Grantee and contractor must advise all insurers of the Agreement

provisions regarding insurance. Non-conforming insurance does not relieve Grantee and contractor of the obligation to provide insurance as specified herein. Non-fulfillment of the insurance conditions may constitute a violation of the Agreement, and the City retains the right to stop work until proper evidence of insurance is provided.

Grantee agrees to make commercially reasonable efforts to obtain from its insurers, when and if available in the industry, a certificate providing that such coverage shall not be suspended, voided, canceled, non-renewed, or reduced in scope or limits except after thirty (30) days' prior written notice by certified mail, return receipt requested, has been given to the City.

Any deductibles or self-insured retentions on referenced insurance coverages must be borne by Grantee and contractor.

The Grantee hereby agrees and will cause its contractors to agree that insurers waive their rights of subrogation against the City of Chicago, its employees, elected officials, agents, or representatives.

The coverages and limits furnished by Grantee and contractor in no way limit the Grantee's and contractor's liabilities and responsibilities specified within the Agreement or by law.

Any insurance or self-insurance programs maintained by the City of Chicago do not contribute with insurance provided by the Grantee and contractor under the Agreement.

The required insurance to be carried is not limited by any limitations expressed in the indemnification language in this Agreement or any limitation placed on the indemnity in this Agreement given as a matter of law.

If Grantee or contractor is a joint venture or limited liability company, the insurance policies must name the joint venture or limited liability company as a named insured.

The Grantee must require the contractor to provide the insurance required herein. All contractors are subject to the same insurance requirements of Grantee unless otherwise specified in this Agreement.

The City's Risk Management Department maintains the right to modify, delete, alter or change these requirements.

11. **Default.** The Grantee shall be in default hereunder in the event of a material breach by Grantee of any term or condition of this Agreement including, but not limited to, a representation or warranty, where Grantee has failed to cure such breach within sixty (60) days after written notice of breach is given to Grantee by City setting forth the nature of such breach. Failure of City to give written notice of breach to Grantee shall not be deemed to be a waiver of the City's right to assert such breach at a later time. If the default is not capable of being cured within the sixty (60) day period, then provided Grantee has commenced to cure the default and is diligently proceeding to cure the default within the sixty (60) day period, and thereafter diligently prosecutes such cure through to completion, then the sixty (60) day period shall be extended for the length of time that is reasonably necessary to cure the default. If the default is not cured in the time period provided for herein, the City may institute such proceedings at law or in equity as may be necessary or desirable to cure and remedy the default, including but

not limited to, termination of this Agreement and removal of the Tunnel at the Grantee's sole expense.

12. **Compliance With Law.** The Grantee agrees that the Public Way Easement Area and Grantee Tunnel shall be used, and any alterations to the Grantee Tunnel shall be constructed, installed, used, operated, inspected, maintained, repaired and replaced in complete compliance with all applicable laws, statutes and ordinances.

13. **Partial Invalidity.** If any clause, sentence or other portion of this Agreement shall become illegal, null or void for any reason, or shall be held by any court of competent jurisdiction to be so, the remaining portion hereof shall remain in full force and effect.

14. **Notices.** Any and all notices or other communications required or permitted pursuant hereto shall be in writing and shall be deemed to have been given if and when personally delivered or on the next following business day if transmitted by reputable overnight carrier. Notices shall be addressed to Grantee and City at their respective addresses set forth below, or to such substitute address as Grantee or City may have designated by notice in accordance herewith:

16) **Illinois Law.** This Agreement has been negotiated, executed and delivered at Chicago, Illinois and shall be construed and enforced in accordance with the laws of Illinois, including the law of public trust with respect to the use and occupation of the public way.

17) **Execution And Recordation of Agreement.** The execution and recordation of this Agreement shall be subject to the finalization of all utility negotiations and further provided that the Grantee supplies the City with sufficient proof of ownership of the Property, and any other documents that the City may deem necessary.

18) **No Third-Party Beneficiaries.** This Agreement shall be binding upon and inure to the benefit solely of Grantee and City and their respective successors, assigns, licensees and legal representatives. This document and the terms hereof are intended solely for the benefit of the parties hereto and their successors, licensee and assigns, as expressly referred to herein. No other person shall have any rights, responsibilities or obligations hereunder nor may such person enforce any of the terms or be entitled to any of the benefits hereof.

19) **Authority and Validity.** Each party represents and warrants to the other party that (i) this Agreement has been duly authorized, executed and delivered by it and (ii) this Agreement constitutes the legal, valid and binding obligation of it, enforceable against it in accordance with its terms.

20) **Miscellaneous.**

(a) The terms, benefits, and privileges set forth in this Agreement shall be deemed and taken to be covenants running with the Property and shall be binding upon the Grantee, its successors and assigns having any interest in the Property.

(b) If any provision of this Agreement, or any paragraph, sentence, clause, phrase, or word or the application thereof is held invalid, illegal, null or void for any reason, or shall be held by any court of competent jurisdiction to be so, the remainder of this Agreement shall be construed as if such invalid part were never included and this Agreement shall be and remain valid and enforceable to the fullest extent permitted by law provided that this Agreement, in its entirety as so reconstituted, does not represent a material change to the rights or obligations of either of the Parties.

(c) In the event the time for performance hereunder falls on a Saturday, Sunday, or legal holiday, the actual time for performance shall be the next business day.

(d) This Agreement and the accompanying Plat shall be governed by, and construed in accordance with, the internal laws of the State of Illinois. In the event that an adjudication of any kind shall be required in connection with this Agreement, the Parties agree that the venue therefor shall be the state or federal courts located in Cook County, Illinois, whichever may be applicable.

(e) This Agreement constitutes the entire contract between the Parties with respect to the subject matter of this Agreement, and may not be modified except by an instrument in writing signed by all the Parties and dated a date subsequent to the date of this Agreement.

(f) Each Party agrees that it will execute and deliver such other reasonable documents and take such other reasonable actions as may be reasonably requested by the other party to effectuate the purposes and intention of this Agreement.

21) **Business Relationships.**

The Grantee acknowledges (A) receipt of a copy of Section 2-156-030 (b) of the Municipal Code of Chicago, (B) that it has read such provision and understands that pursuant to such Section 2-156-030 (b) it is illegal for any elected official of the City, or any person acting at the direction of such official, to contact, either orally or in writing, any other City official or employee with respect to any matter involving any person with whom the elected City official or employee has a "Business Relationship" (as defined in Section 2-156-080 of the Municipal Code of Chicago), or to participate in any discussion in any City Council committee hearing or in any City Council meeting or to vote on any matter involving the person with whom an elected official has a Business Relationship, and (c) notwithstanding anything to the contrary contained in this Agreement, that a violation of Section 2-156-030 (b) by an elected official, or any person acting at the direction of such official, with respect to any transaction contemplated by this Agreement shall be grounds for termination of this Agreement and the transactions contemplated hereby. The Grantee hereby represents and warrants that no violation of Section 2-156-030 (b) has occurred with respect to this Agreement or the transactions contemplated hereby.

22) **Patriot Act Certification.**

The Grantee represents and warrants that neither the Grantee nor any Affiliate thereof (as defined in the next paragraph) is listed on any of the following lists maintained by the Office of Foreign Assets Control of the U.S. Department of the Treasury, the Bureau of Industry and Security of the U.S. Department of Commerce or their successors, or on any other list of persons or entities with which the City may not do business under any applicable law, rule, regulation, order or judgment: the Specially Designated Nationals List, the Denied Persons List, the Unverified List, the Entity List and the Debarred List.

As used in the above paragraph, an "Affiliate" shall be deemed to be a person or entity related to the Grantee that, directly or indirectly, through one or more intermediaries, controls, is controlled by or is under common control with Grantee, and a person or entity shall be deemed to be controlled by another person or entity, if controlled in any manner whatsoever that results in control in fact by that other person or entity (or that other person or entity and any persons or entities with whom that other person or entity is acting jointly or in concert), whether directly or indirectly and whether through share ownership, a trust, a contract or otherwise.

23) **Prohibition on Certain Contributions Mayoral Executive Order 2011-4.**

Grantee agrees that Grantee, any person or entity who directly or indirectly has an ownership or beneficial interest in Grantee of more than 7.5 percent ("Owners"), spouses and domestic partners of such Owners, Grantee's contractors (i.e., any person or entity in direct contractual privity with Grantee regarding the subject matter of this Agreement) ("Contractors"), any person or entity who directly or indirectly has an ownership or beneficial interest in any Contractor of more than 7.5 percent ("Sub-owners") and spouses and domestic partners of such Sub-owners (Grantee and all the other preceding classes of persons and entities are together, the "Identified Parties"), shall not make a contribution of any amount to the Mayor of the City of Chicago (the "Mayor") or to his political fundraising committee (i) after execution of this Agreement by Grantee, (ii) while this Agreement or any Other Contract is executory, (iii) during

the term of this Agreement or any Other Contract between Grantee and the City, or (iv) during any period while an extension of this Agreement or any Other Contract is being sought or negotiated.

Grantee represents and warrants that from the later to occur of (a) May 16, 2011, and (b) the date the City approached the Grantee or the date the Grantee approached the City, as applicable, regarding the formulation of this Agreement, no Identified Parties have made a contribution of any amount to the Mayor or to his political fundraising committee.

Grantee agrees that it shall not: (a) coerce, compel or intimidate its employees to make a contribution of any amount to the Mayor or to the Mayor's political fundraising committee; (b) reimburse its employees for a contribution of any amount made to the Mayor or to the Mayor's political fundraising committee; or (c) Bundle or solicit others to bundle contributions to the Mayor or to his political fundraising committee.

Grantee agrees that the Identified Parties must not engage in any conduct whatsoever designed to intentionally violate this provision or Mayoral Executive Order No. 2011-4 or to entice, direct or solicit others to intentionally violate this provision or Mayoral Executive Order No. 2011-4.

Grantee agrees that a violation of, non-compliance with, misrepresentation with respect to, or breach of any covenant or warranty under this provision or violation of Mayoral Executive Order No. 2011-4 constitutes a breach and default under this Agreement, and under any Other Contract for which no opportunity to cure will be granted, unless the City, in its sole discretion, elects to grant such an opportunity to cure. Such breach and default entitles the City to all remedies (including without limitation termination for default) under this Agreement, under any Other Contract, at law and in equity. This provision amends any Other Contract and supersedes any inconsistent provision contained therein.

If Grantee intentionally violates this provision or Mayoral Executive Order No. 2011-4 prior to the closing of this Agreement, the City may elect to decline to close the transaction contemplated by this Agreement.

For purposes of this provision:

"Bundle" means to collect contributions from more than one source, which is then delivered by one person to the Mayor or to his political fundraising committee.

"Other Contract" means any other agreement with the City of Chicago to which Grantee is a party that is (i) formed under the authority of chapter 2-92 of the Municipal Code of Chicago; (ii) entered into for the purchase or lease of real or personal property; or (iii) for materials, supplies, equipment or services which are approved or authorized by the City Council of the City of Chicago.

"Contribution" means a "political contribution" as defined in Chapter 2-156 of the Municipal Code of Chicago, as amended.

Individuals are "Domestic Partners" if they satisfy the following criteria:

- (A) they are each other's sole domestic partner, responsible for each other's common welfare; and

- (B) neither party is married; and
- (C) the partners are not related by blood closer than would bar marriage in the State of Illinois; and
- (D) each partner is at least 18 years of age, and the partners are the same sex, and the partners reside at the same residence; and
- (E) two of the following four conditions exist for the partners:
 - 1. The partners have been residing together for at least 12 months.
 - 2. The partners have common or joint ownership of a residence.
 - 3. The partners have at least two of the following arrangements:
 - a. joint ownership of a motor vehicle;
 - b. a joint credit account;
 - c. a joint checking account;
 - d. a lease for a residence identifying both domestic partners as tenants.
 - 4. Each partner identifies the other partner as a primary beneficiary in a will.

"Political fundraising committee" means a "political fundraising committee" as defined in Chapter 2-156 of the Municipal Code of Chicago, as amended.

24) Failure To Maintain Eligibility To Do Business With The City.

Failure by Grantee or any controlling person (as defined in Section 1-23-010 of the Municipal Code of Chicago) thereof to maintain eligibility to do business with the City of Chicago as required by Section 1-23-030 of the Municipal Code of Chicago shall be grounds for termination of the Agreement and the transactions contemplated thereby. Grantee shall at all times comply with Section 2-154-020 of the Municipal Code of Chicago.

25) Inspector General and Legislative Inspector General.

It is the duty of every officer, employee, department, agency, contractor, subcontractor, Grantee and licensee of the City, and every applicant for certification of eligibility for a City contract or program, to cooperate with the City's Legislative Inspector General and with the City's Inspector General in any investigation or hearing undertaken pursuant to Chapters 2-55 and 2-56, respectively, of the Municipal Code of Chicago. The Grantee understands and will abide by all provisions of Chapters 2-55 and 2-56 of the Municipal Code of Chicago.

26) **Waste Ordinance Provisions.**

In accordance with Section 11-4-1600(e) of the Municipal Code of Chicago, Grantee warrants and represents that it, and to the best of its knowledge, its contractors and subcontractors, have not violated and are not in violation of any provisions of Section 7-28 or Section 11-4 of the Municipal Code (the "Waste Sections"). During the period while this Agreement is executory, Grantees, any general contractors or any subcontractors violation of the Waste Sections, whether or not relating to the performance of this Agreement, constitutes a breach of and an event of default under this Agreement, for which the opportunity to cure, if curable, will be granted only at the sole designation of the Chief Procurement Officer. Such breach and default entitles the City to all remedies under the Agreement, at law or in equity. This section does not limit Grantees, general contractors and its subcontractor's duty to comply with all applicable federal, state, county and municipal laws, statutes, ordinances and executive orders, in effect now or later, and whether or not they appear in this Agreement. Non-compliance with these terms and conditions may be used by the City as grounds for the termination of this Agreement, and may further affect Grantee's eligibility for future contract awards.

27) **Shakman Accord.**

(a) The City is subject to the May 31, 2007 Order entitled "Agreed Settlement Order and Accord" (the "Shakman Accord") and the August 16, 2007 "City of Chicago Hiring Plan" (the "City Hiring Plan") entered in Shakman v. Democratic Organization of Cook County, Case No 69 C 2145 (United States District Court for the Northern District of Illinois). Among other things, the Shakman Accord and the City Hiring Plan prohibit the City from hiring persons as governmental employees in non-exempt positions on the basis of political reasons or factors.

(b) Grantee is aware that City policy prohibits City employees from directing any individual to apply for a position with Grantee, either as an employee or as a subcontractor, and from directing Grantee to hire an individual as an employee or as a subcontractor. Accordingly, Grantee must follow its own hiring and contracting procedures, without being influenced by City employees. Any and all personnel provided by Grantee under this Agreement are employees or subcontractors of Grantee, not employees of the City of Chicago. This Agreement is not intended to and does not constitute, create, give rise to, or otherwise recognize an employer-employee relationship of any kind between the City and any personnel provided by Grantee.

(c) Grantee will not condition, base, or knowingly prejudice or affect any term or aspect to the employment of any personnel provided under this Agreement, or offer employment to any individual to provide services under this Agreement, based upon or because of any political reason or factor, including, without limitation, any individual's political affiliation, membership in a political organization or party, political support or activity, political financial contributions, promises of such political support, activity or financial contributions, or such individual's political sponsorship or recommendation. For purposes of this Agreement, a political organization or party is an identifiable group or entity that has as its primary purpose the support of or opposition to candidates for elected public office. Individual political activities are the activities of individual persons in support of or in opposition to political organizations or parties or candidates for elected public office.

(d) In the event of any communication to Grantee by a City employee or City official in violation of Section 27 (ii) above, or advocating a violation of Section 27 (ii) above, Grantee will, as soon as is reasonably practicable, report such communication to the Hiring Oversight Section

of the City's Office of the Inspector General ("IGO Hiring Oversight"), and also to the head of the relevant City Department utilizing services provided under this Agreement. Grantee will also cooperate with any inquiries by IGO Hiring Oversight or the *Shakman* Monitor's Office related to the contract.
