BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1- 2 District symbols and indications as shown on Map No.13-J in the area bounded by

The alley next north of and parallel to West Lawrence Avenue; North Avers Avenue; West Lawrence Avenue; and a line 132 feet west of and parallel to North Avers Avenue,

to those of a B3- 2 District and a corresponding uses district is hereby established in the area above described.

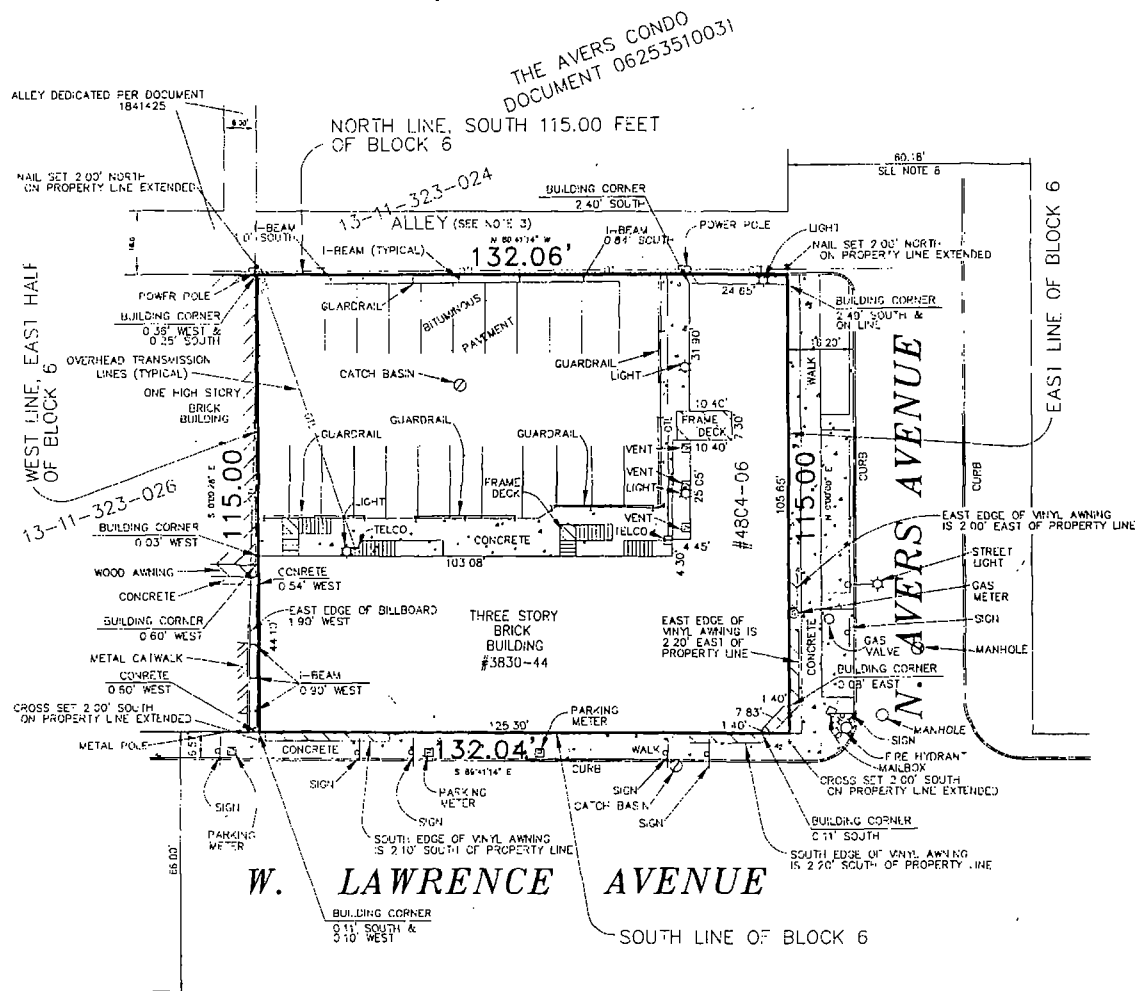
