BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Park District symbols and indications as shown on Map No:7-H in the area bounded by

a line 325 feet northwesterly of and parallel to North Marshfield Avenue
(as measured at the at the easterly right-of-way line of North Clybourn
Avenue); the alley next northeasterly of and parallel to North Clybourn
Avenue; a line 300 feet northwesterly of and parallel to North Marshfield
Avenue (as measured at the easterly right-of-way line of North Clybourn
Avenue),

to those of a RM4.5 Residential Multi-Unit District and a corresponding use district is
hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage
and due publication.









N 2ND FLOOR PLAN


SOUTH ELEVATION
