#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the C1-2 Neighborhood Commercial District symbols and indications as shown on Map No. 1-H in the area bounded by:

West Grand Avenue; a line 79.00 feet east of North Western Avenue; a line 105.00 feet south of West Grand Avenue; and North Western Avenue

to those of a C1-3 Neighborhood Commercial District which is hereby established in the area described above

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.






#### 2351 - 59 West Grand Avenue/463- 75 North Western Avenue TYPE I REGULATIONS


Narrative: The subject property contains 10,112 square feet and is currently improved with 1) a three-story mixed-use building at 2355 West Grand Avenue containing ground floor commercial space and three residential dwelling units; 2) a one-story commercial building at 2351 West Grand Avenue; and 3) a vacant parcel. The current zoning for the property is C1-2. The Applicant proposes to change the zoning to a C1-3 to allow for the establishment of a fourth residential dwelling unit in the 2355 West Grand Avenue building. No expansion of or additions to the existing improvements are proposed.








