BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 13-H in an area bound by

The public alley next West of and parallel to North Ashland Avenue, a line 82 feet South of and parallel to West Balmoral Avenue, North Ashland Avenue, a line 107 feet South of and parallel to West Balmoral Avenue


to those of an RM4.5 Residential Multi-Unit District.
