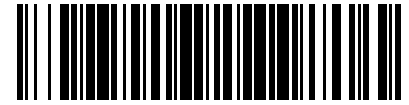

ORDINANCE

to those of a B1-3 Neighborhood Shopping District.

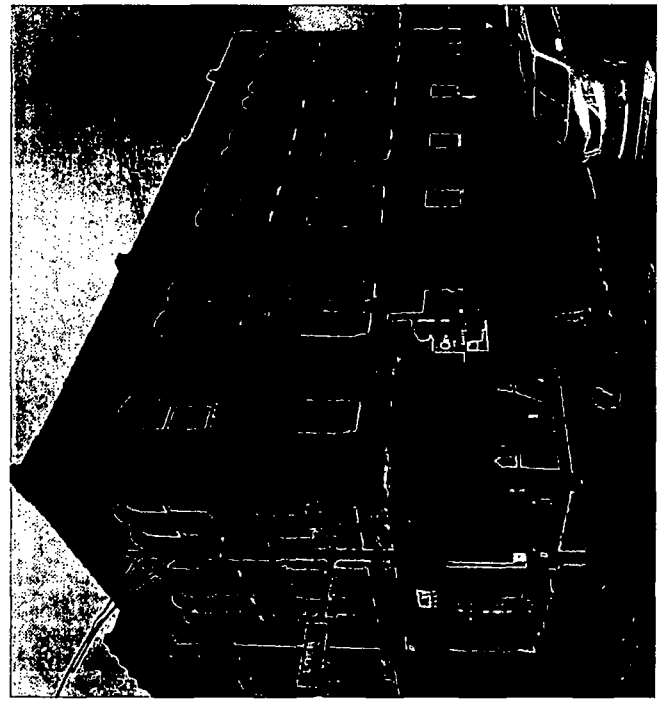
