ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning

Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit

(Detached House) District symbols as shown on Map No. 5-I

in the area bounded by:

A line 54.40 feet North of and parallel to West Wabansia Avenue; North Washtenaw

Avenue; a line 29.40 feet North of and parallel to West Wabansia Avenue; the public

alley next West of and parallel to North Washtenaw Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.


