**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 6-J in the area bounded by:**

**A line 253 feet North of and parallel to West 28th Street; a public alley next East of and parallel to South Pulaski Road; a line 203 feet North of and parallel to West 28<sup>th</sup> Street; South Pulaski Road.**

**To those of a B2-1, Neighborhood Mixed-Use District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**

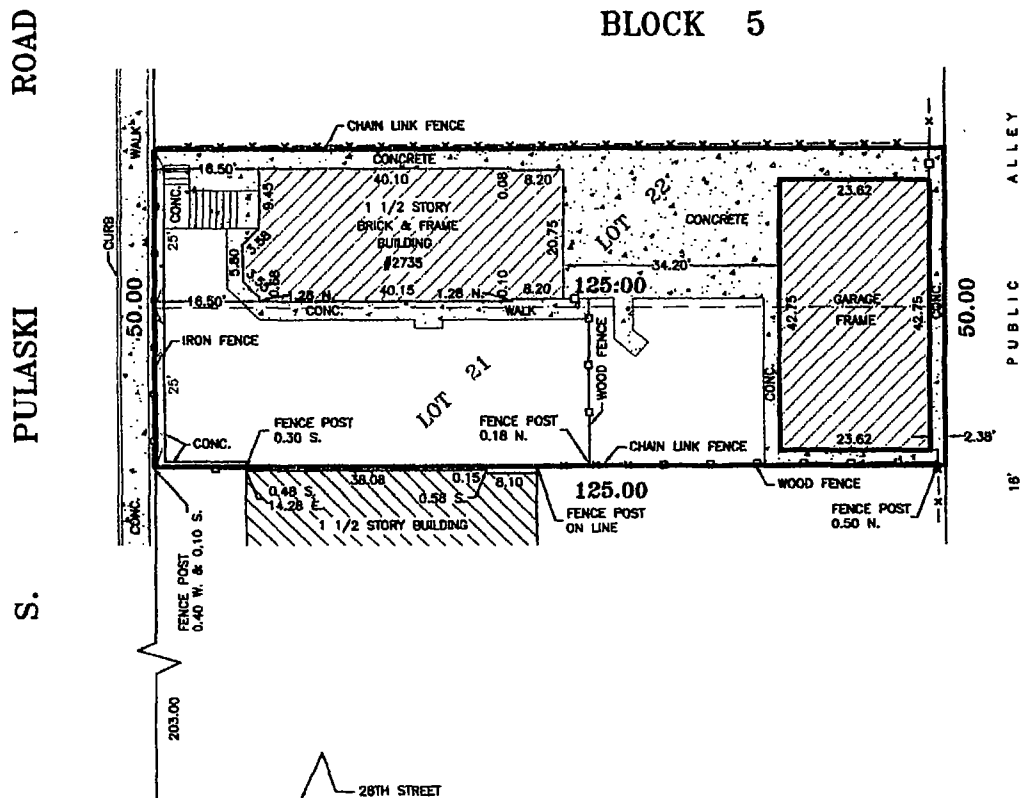
