13 5800-5899 South Kilbourn Avenue; Amend Residential Permit Parking Zone 345, which reads: 5800-5899 South Kilbourn Avenue (north and south sides) from west 58th Street to West 59th Street, and on West 58th Street (south side) from South Kilbourn Avenue east to the first alley and from South Kilbourn Avenue west to the first alley, All Times, All Days, by Striking: Residential Permit Parking Zone 345 and Inserting: a new Residential Permit Parking Zone number, in lieu thereof [O2017-8625]

WARD SINGLE DIRECTION:

31 North Kostner Avenue; North Kostner Avenue between West Diversey Avenue and West Belmont Avenue: Single Direction - Southerly. Not Recommended. Traffic Engineering survey indicates proposed one way change would result in hazardous community access problems -- (17-04762908) [O2017-5354]

WARD TRAFFIC WARNING SIGNS AND/OR SIGNALS:

- 19 South Longwood Drive and West 101st Place; Stop Sign. Not Recommended. Duplicate Proposal previously Passed 12/13/2017. Signs will be installed --(17-08067463) [O2017-8368]
- 19 South Homan Avenue; No Trucks Sign. Not Recommended: Duplicate proposal previously Passed 12/13/2017. Signs will be installed -- (17-08067817) [O2017-8366]
