BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit
(Detached House) District symbols as shown on Map No. 8 - G
in the area bounded by:

A line 96 feet North of and parallel to West 32<sup>nd</sup> Street; the public alley next East of and parallel to South May Street; a line 72 feet North of and parallel to West 32nd Street; South May Street.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.
