

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the C3-2 Commercial, Manufacturing and Employment

District symbols and indications as shown on Map No 1-H in the area bounded by

a line 52.40 feet north of and parallel to West Grand Avenue; North Hermitage Avenue; West Grand Avenue; and the alley next west of and parallel to North Hermitage Avenue,

to those of a B1-3 Neighborhood Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

PLAT OF SURVEY


