**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District, as shown on Map 11-J in the area bounded by:

**A line 186 feet North of and parallel to West Irving Park Road; the alley East of and parallel to North Monticello Avenue; a line 162.00 feet North of and parallel to West Irving Park Road; and North Monticello Avenue.**

To those of **B2-2** Neighborhood Mixed-Use District

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.

**NARRATIVE AND PLANS  
FOR THE PROPOSED REZONING  
AT  
4017 NORTH MONTICELLO AVENUE**

The Application is to change zoning for 4017 North Monticello Avenue from RS-3 Residential Single-Unit (Detached House) to B2-2 Neighborhood Mixed-Use District. The Applicant intends to construct a three-story, three dwelling unit building with a basement. The footprint of the building shall be approximately be 23 feet 6 inches by 79 feet 4 in size. The building height shall be 35 feet 10 inches high, as defined by code.

**FLOOR AREA RATIO:** 1.55

**BUILDING AREA:** 4,659 SQUARE FEET
