BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District, as shown on Map 11-J in the area bounded by:

A line 186 feet North of and parallel to West Irving Park Road; the alley East of and parallel to North Monticello Avenue; a line 162.00 feet North of and parallel to West Irving Park Road; and North Monticello Avenue.

To those of **B2-2** Neighborhood Mixed-Use District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

NARRATIVE AND PLANS FOR THE PROPOSED REZONING AT 4017 NORTH MONTICELLO AVENUE

The Application is to change zoning for 4017 North Monticello Avenue from RS-3 Residential Single-Unit (Detached House) to B2-2 Neighborhood Mixed-Use District. The Applicant intends to construct a threestory, three dwelling unit building with a basement. The footprint of the building shall be approximately be 23 feet 6 inches by 79 feet 4 in size. The building height shall be 35 feet 10 inches high, as defined by code.
