BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 Neighborhood Commercial District, as shown on Map 6-H in the area bounded by:

West Cermak Road, a line 126 feet West and parallel to South Wood Street, the alley south of and parallel to West Cermak Road and a line 150 feet West and parallel to South Wood Street.

To those of **B2-3 Neighborhood Mixed-Use District**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about February 21, 2018, the undersigned will file an application for a change in zoning from C1-2 Neighborhood Commercial Districtto B2-3 Neighborhood Mixed-Use District for the property located at 1813 West Cermak Road, Chicago, Illinois.

The Applicant intends to construct a two-story, three dwelling unit building with basement. There will be three parking spaces provided at the rear of the property. The footprint of the building shall be approximately 24 feet by 70 feet and the building shall be 26 feet high, as defined by City Code.
