INTRO DATE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District, as shown on Map 4-H in the area bounded by:

West Cullerton Street, a line 120 feet West of South Paulina Street, the alley next south of and parallel to West Cullerton Street and a line 144 feet West of South Paulina Street, except a triangle at the northwest corner of said parcel 7.0 feet by 10 feet in size, the hypotenuse of said triangle being 12.20 feet.

To those of B2-3 Neighborhood Mixed-Use District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about February 21, 2018, the undersigned will file an application for a change in zoning from B3-2 Community Shopping District to B2-3 Neighborhood Mixed-Use District for the property located at 1713 West Cullerton Street, Chicago, Illinois.

The Applicant intends to construct a two-story, three dwelling unit building with basement. There will be three parking spaces provided at the rear of the property.
