BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by:

A line 262.30 feet north of the northeasterly line of north Milwaukee Avenue as measured along the west line of North Wood Street; North Wood Street; a line 212.30 feet north of the northeasterly line of north Milwaukee avenue as measured along the west line of North Wood Street; a line from a point on the immediately aforementioned line 82.20 feet west of North Wood Street as measured perpendicular thereto running northwesterly for a distance of 54.80 feet to a point on the line first mentioned above 104.80 feet west of North Wood Street, as measured perpendicular thereto

to those of a RM-5 Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.






