BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

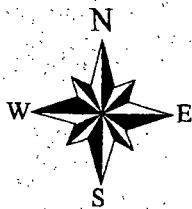
SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.13-J in the area bounded by

a line 149 feet south of and parallel to West Argyle Avenue; North Monticello Avenue; a line 179 feet south of and parallel to West Argyle Avenue; and the alley next west of and parallel to North Monticello Avenue,

to those of a RT3.5 Residential Two-flat, Townhouse and Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

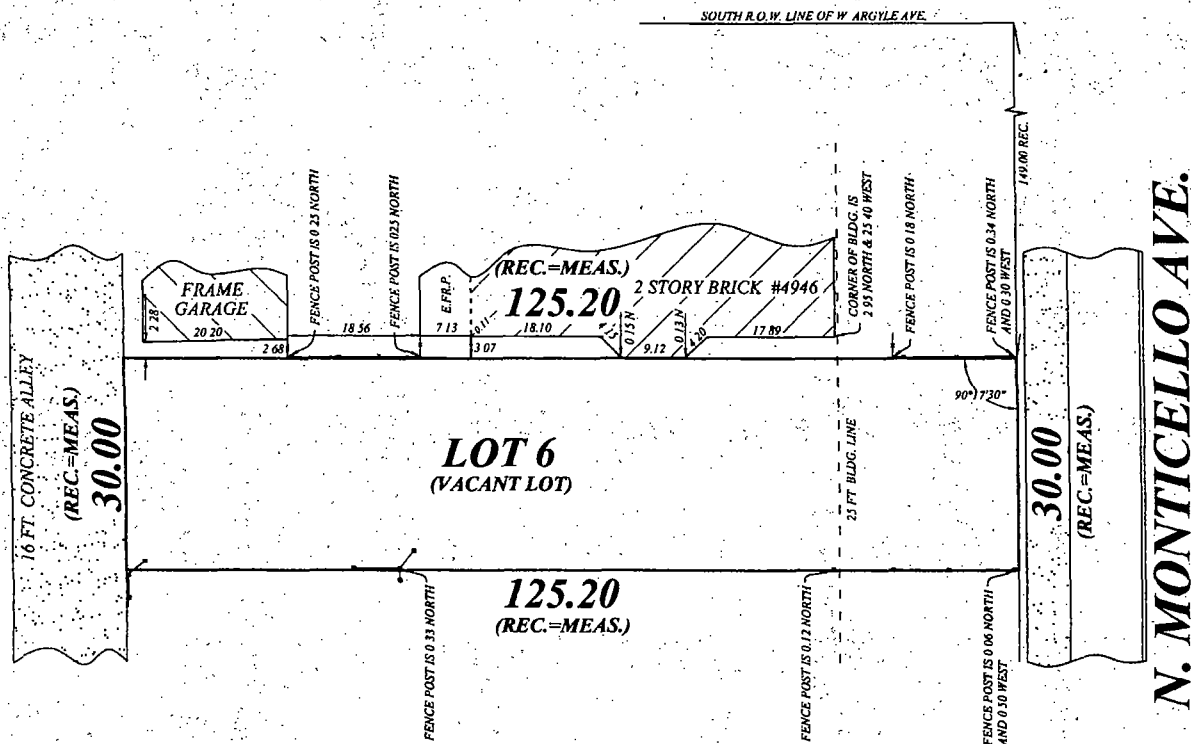
