ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map Number 4-G in the area bounded by:

a line 100.00 feet south of and parallel to West 18<sup>th</sup> Street; the alley next east of and parallel to South Laflin Street; a line 125.00 feet south of and parallel to West 18<sup>th</sup> Street; and South Laflin Street

to those of an RM-4.5 Residential Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 20, 2018, the undersigned will file an application for a change in zoning from RT4 Residential Two-Flat, Townhouse and Multi-Unit District to RM4.5 Residential Multi-Unit District on behalf of the applicant, **Rana Sharma Homes, LLC Laflin Series**, for the property located at 1811 S.
