#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


Section1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the **RS-3** (residential single unit detached house) District symbols and indications as shown on Map No. **5-J** in the area bounded by:

A line 383.0' feet South of and parallel to West Cortland St.; a line 177.0' feet East of and parallel to North Kimball Ave.; A line 410.0' feet South of and parallel to West Cortland St.; and North Kimball Ave.

To those of a **RM 4.5** Residential Multi-unit District

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.


