ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the DX-5 Downtown Mixed-Use District symbols and indications as shown on Map No. 2-H in the area bounded by

a line 245 feet north of and parallel to West Van Buren Street;
South Halsted Street; a line 195 feet north of and parallel to
West Van Buren Street; and a line 125 feet west of and parallel
to South Halsted Street,

to those of a DX-5 Downtown Mixed-Use District and a corresponding use district is
hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage
and due publication.


