ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No 9-H in the area bounded by:

West Irving Park Road; a line 81.06 feet west of and parallel to North Marshfield Avenue; the 16.00 foot alley next south of West Irving Park Road; and a line 106.06 feet west of and parallel to North Marshfield Avenue.

To those of a B2-2 Neighborhood Mixed-Use District and an accompanying use district is hereby established in the area described above.

SECTION 2. This ordinance takes effect after its passage and due publication.
