## **ORDINANCE**

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.5-K in the area bounded by

a line 194 feet south of and parallel to West Wabansia Avenue; the alley next east of and parallel to North Keystone Avenue; a line 229 feet south of and parallel to West Wabansia Avenue; and North Keystone Avenue,

to those of a RT4 Residential Two Flat, Townhouse and Multi-Unit District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.
