BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit
(Detached House) District symbols as shown on Map No. 5-L
in the area bounded by:

A line 100 feet north of and parallel to West Dickens Avenue; North Laramie Avenue; a line 50 feet north of and parallel to West Dickens Avenue; the public alley next west of and parallel to North Laramie Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.





In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about March 20, 2018 the undersigned will file an Application for a change in zoning from an RS3 Residential Single-Unit (Detached House) District to an RM4.5 Residential Multi-Unit District on behalf of the Applicant, 4342 W. Shakespeare, LLC, for the property located at 2106-08 North Laramie Avenue, Chicago, Illinois.

The subject property is currently improved with a residential building with 2 dwelling units at 2108 North Laramie Ave. and the lot at 2106 North Laramie Avenue is vacant.
