ORDINANCE

#19601
INTRO DATE
MARCH 28, 2018

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 6-K in the area bounded by

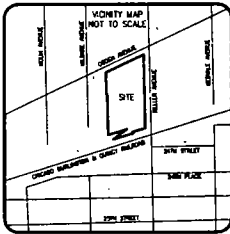
West Ogden Avenue; South Keeler Avenue; a line beginning at a point 553.65 feet south of West Ogden Avenue, as measured along the west line of South Keeler Avenue, extending southwesterly 95 feet to a point 10 feet northwesterly of the northwesterly line of the Chicago Burlington & Quincy Railroad right-of-way; a line beginning at last said point, extending southeasterly 10 feet to a point 92 feet southwesterly of South Keeler Avenue, as measured along the northwesterly line of the Chicago Burlington & Quincy Railroad right-of-way; the northwesterly line of the Chicago Burlington & Quincy Railroad right-of-way; a line beginning at a point along the northwesterly line of the Chicago Burlington & Quincy Railroad right-of-way, 242 feet southwesterly of South Keeler Avenue, extending 124.77 feet northeasterly to a point 134.92 feet southwesterly of South Keeler Avenue, as measured along a line 40 feet north of and parallel to the northwesterly line of the Chicago Burlington & Quincy Railroad right-of-way; a line beginning at last said point and extending 141.64 feet southwesterly to a point 136 feet east of South Kildare Avenue and 40 feet northwesterly of the northwesterly line of the Chicago Burlington & Quincy Railroad right-of-way; a line 136 feet east of and parallel to South Kildare Avenue; a line 283.69 feet north of the last said point as measured along the last said line and perpendicular thereto; a line 133 feet east of and parallel to South Kildare Avenue; a line 8.63 feet north of the last said east/west line as measured along a line 133 feet east of and parallel to South Kildare Avenue and perpendicular thereto; and a line 130 feet east of and parallel to South Kildare Avenue,

to those of a M2-2 Light Industry District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
