Approval of plat of UCAN Plat of Resubdivision Committee on Transportation and Public Way

SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. The Commissioner of the Chicago Department of Transportation, or any of her designees, is each hereby authorized and directed to approve a proposed UCAN Plat of Resubdivision being a resubdivision of certain lots owned by UCAN Holding Company, an Illinois not for profit corporation, and UCAN Title Holding Company II (2), an Illinois not for profit corporation (collectively the "Developers") approximately bounded by W. Taylor Street, W. Grenshaw Street, S. Independence Boulevard and S. Central Park Avenue as legally described in the attached plat (Exhibit A, CDOT File: 14-24-16-3773) which, for greater certainty, is hereby made a part of this ordinance.


SECTION 2. The resubdivision herein provided for is made upon the express condition that preexisting reservations for the Chicago Water Department for mains, sewers and associated appurtenances, along with a reservation for Peoples Gas, both on vacated W. Fillmore Street between the west line of S. Central Park Avenue and approximately S. Independence Boulevard, the terms of which were recorded June 15th, 2012 as document 1216739096, remain in place.

SECTION 3. The resubdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developers shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the full sized corresponding Plat approved by the Department of Transportation's Acting Superintendent of Maps and Plats.


SECTION 4. This ordinance and resubdivision plat exhibit shall take effect and be in force from and after their recording.




