ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C 1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 7-G in an area bound by

A line 150 feet west of and parallel to North Racine Avenue; the alley next North of and parallel to West Fletcher Street; a line 125 feet West of and parallel to North Racine Avenue, West Fletcher Street

to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District. SECTION 2. This ordinance takes effect after its passage and due publication.


