BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 26-J in an area bound by

A line 125 feet West of and parallel to South Kedzie Avenue; a line 70 feet North of and parallel to West 108<sup>th</sup> Street; South Kedzie Avenue; West 108<sup>th</sup> Street.

to those of a B3-1 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.
