ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No.11-1 in the area bounded by

West Lawrence Avenue; a line 83.38 feet west of and parallel to North Talman Avenue; the alley next south of and parallel to West Lawrence Avenue; and a line 108.38 feet west of and parallel to North Talman Avenue,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

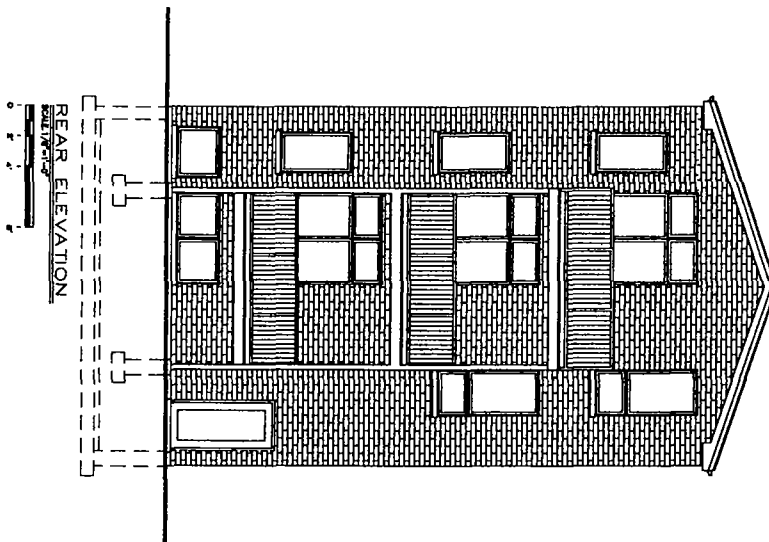
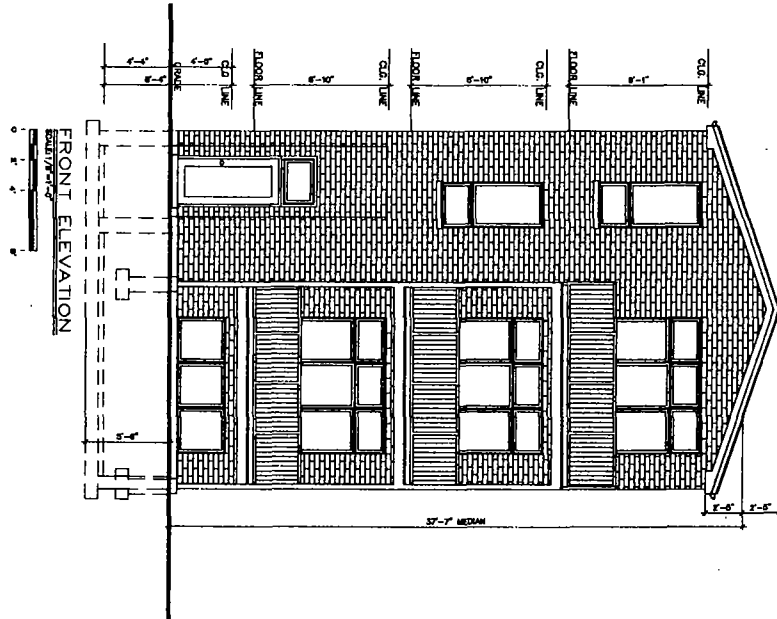


3RD FLOOR PLAN

 6 UNIT APARTMENT BUILDING

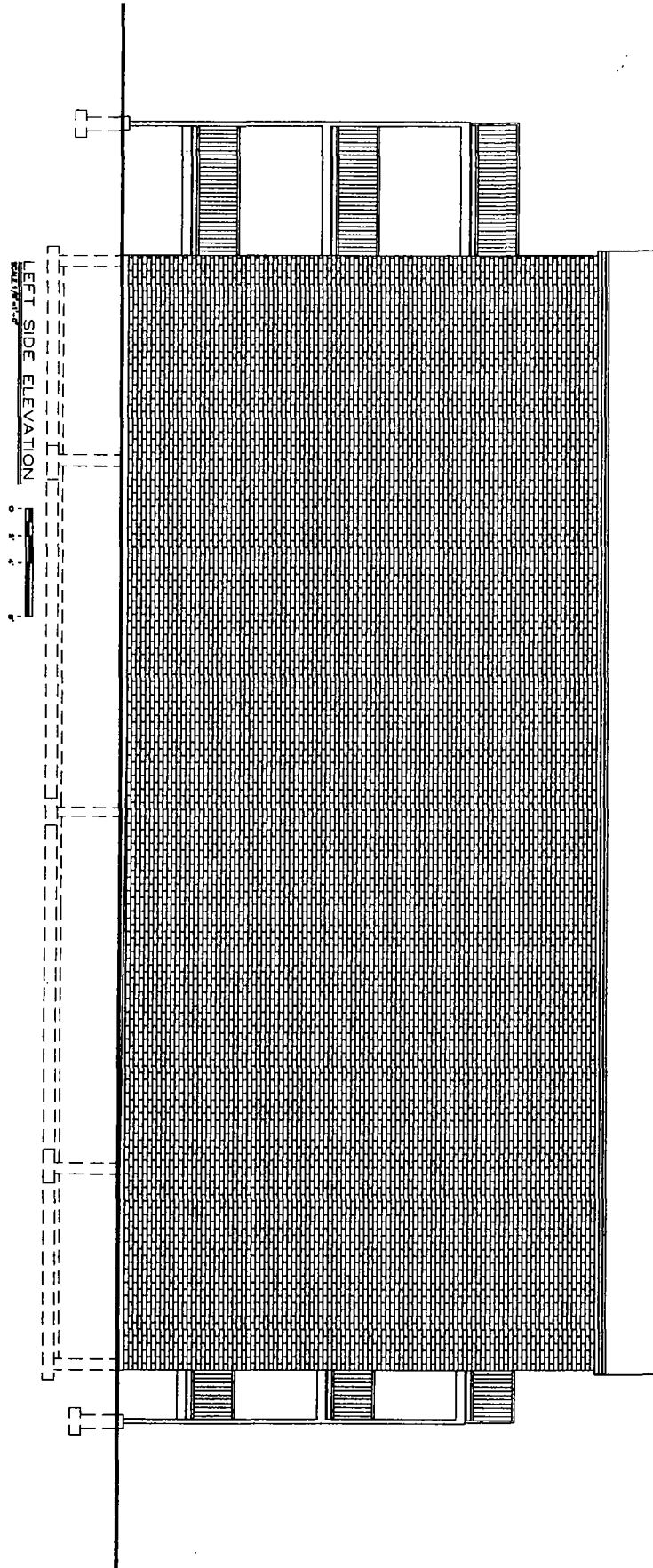

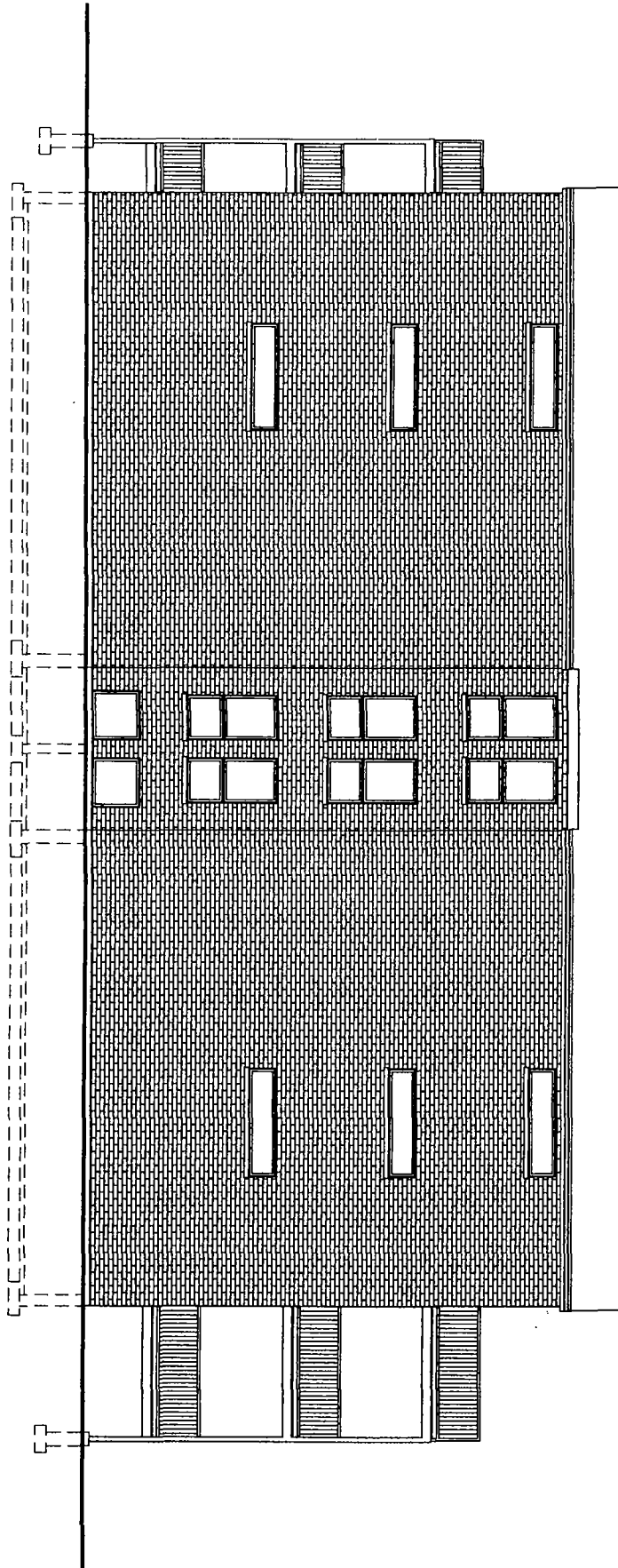
LEFT SIDE ELEVATION
