ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the C1-2, Neighborhood Commercial District symbols as shown on Map No. 4-H in the area bounded by:

A line 80 feet north of and parallel to West 19th Street; a line 83 feet east of and parallel to South Western Avenue; a line 52 feet north of and parallel to West 19th Street; South Western Avenue.

To those of a B2-5, Neighborhood Mixed-Use District


