Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to REAL GOOD JUICE CO. upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 1647 N. Wells St.. Said sidewalk cafe area #1 shall be fourteen point six seven (14.67) feet in length and nine (9) feet in width for a total of one hundred thirty-two point zero three (132.03) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along N Wells St. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Thursday 8:00am to 9:00pm
Friday 8:00am to 7:00pm
Saturday 8:30am to 7:00pm
Sunday 8:00am to 5:30pm
Compensation: \$600.00
SEATING CAPACITY: 8

Sidewalk Cafe Permit and approved plan must be posted at all times:

This grant of privilege #1133937 for a sidewalk cafe shall be subject to the provisions of Section 10-28-800 through 10-28-885 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority for the above named privilege is herein given and granted from and after March 1, 2018 through and including December 1, 2018.
