ORDINANCE

BE-IT-ORDAINED BY THE CITY-COUNCIL OF THE-CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District, as shown on Map 13-H in the area bounded by:

West Foster Avenue, a line 126.42 feet East of and parallel to North Western Avenue, the alley North of and parallel to West Foster Avenue; and a line 156.42 feet East of North Western Avenue.

To those of RM-4.5 Residential Multi-Unit District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

NARRATIVE AND PLANS FOR THE PROPOSED REZONING AT 2342 WEST FOSTER AVENUE

The Application is to change zoning for 2342 West Foster Avenue from B1-2 Neighborhood Shopping District to RM-4.5 Residential Multi-Unit District. The Applicant intends to construct a three-story building with basement, consisting of three dwelling units. There will be three garage parking spaces. The footprint of the building shall be approximately 24 feet by 70 feet in size. The building height shall be 34 feet 6 inches high, as defined by City Code.
