#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the B3-2, Community Shopping
District symbols as shown on Map No. 5-I
in the area bounded by:

A line 56 feet south of and parallel to West Belden Avenue; North Western Avenue; a line 84 feet south of and parallel to West Belden Avenue; the public alley next west of and parallel to North Western Avenue.

To those of a B3-3, Community Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 19, 2018, the undersigned will file an Application for a change in zoning from a B3-2 Community Shopping District to a B3-3 Community Shopping District, on behalf of the Applicant, MF GROUP LLC, an Illinois limited liability company, for the property located at 2246 North Western Avenue, Chicago, Illinois.

The subject property is currently a vacant lot. The Applicant intends to build a new four-story mixed-use building with a commercial unit on the ground floor and three dwelling units on the upper floors. The Applicant needs a zoning change in order to comply with the minimum lot area and the maximum floor area requirements of the Zoning Ordinance.
