WESTIN HOTEL CHICAGO

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to WESTIN HOTEL CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Siamese Connection(s) projecting over the public right-of-way adjacent to its premises known as 909 N. Michigan Ave...

Said Siamese Connection(s) at East Delaware measure(s):

Two (2) at one point nine two (1.92) foot in length, and point three three (.33) feet in width for a total of one point two seven (1.27) square feet.

One (1) at two point eight three (2.83) feet in length, and point three three (.33) feet in width for a total of point nine three (.93) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1134269 herein granted the sum of one thousand two hundred (\$1,200.00) per annum in advance.


A 25% penalty will be added for payments received after due date.


