#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C2-2 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No.8-H in the area bounded by:


West 33<sup>rd</sup> Street; a line 150 feet West of and parallel to South Wood Street; The public alley next south of and parallel to west 33<sup>rd</sup> Street; and a line 175 feet west of and parallel to South Wood Street.

To those of a RS-3 Residential Single-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about July 10,2018, the undersigned will file an application for a change in zoning from C2-2 zoning district to a RS-3 zoning district on behalf of Anthony Moy for the property located at 1817 W. 33<sup>rd</sup> Street, Chicago, Il 60608.

The Applicant is proposing to tear down the existing unoccupied two-story apartment building and construct a one-story single-family home with a 2-car garage. The Applicant intends to keep the existing residential use of the land. The Applicant does not intend to have commercial use.

The Applicant believes the zoning amendment project aims to achieve the purpose and intent identified in the Chicago Zoning Ordinance and Land Use Ordinance (Title 17-1-0500). The Applicant is mindful to preserve the overall quality of life for residents and visitors while protecting the character of the neighborhood.
