ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C2-2 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No 1-H in the area bounded by

a line 105 feet north of and parallel to West Grand Avenue; North Leavitt Street; West Grand Avenue; a line 192 feet west of and parallel to North Leavitt Street; the alley next north of and parallel to West Grand Avenue; and the alley next west of and parallel to North Leavitt Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
