# **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1**: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the B1-2 Neighborhood Shopping District and RM5 Residential Multi-Unit District symbols and indications as shown on Map No. 20-G in the area bounded by:

West 79th Street; South Green Street; the public alley next south of and parallel to West 79th Street;

South Peoria Street

to those of a B3-5 Community Shopping District, which is hereby established in the area described.

**SECTION 2**: This ordinance shall take effect upon its passage and due publication.






