ORDINANCE

#19736 INTRO DATE JULY 25,2018

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current RT4 Residential Two-flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 6-I in the area bounded by:

West Luther Street; a line 50.0 feet east of South Washtenaw Avenue; the public alley next south of West Luther Street; and South Washtenaw

to those of a RT4.5 Residential Two-flat, Townhouse and Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.




