ORDINANCE WALGREENS #11410 Acct. No. 7551 - 83 Permit No. 1134943

Be It Ordained by the City Council of the City of Chicago.

SECTION 1 Permission and authority are hereby given and granted to WALGREENS #11410, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, five (5) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 1627 N. Pulaski Rd

Said Canopy(s) at N Pulaski Rd measure(s):

Five (5) at fifteen point four two (15.42) feet in length, and five (5) feet in width for a total of three hundred eighty-five point five (385.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1134943 herein granted the sum of one hundred seventy-five (\$175 00) per annum in advance


A 25% penalty will be added for payments received after due date


