

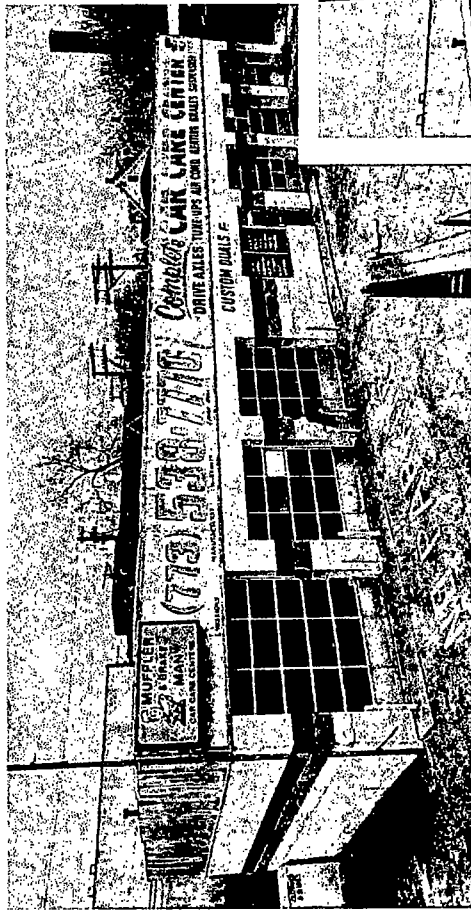

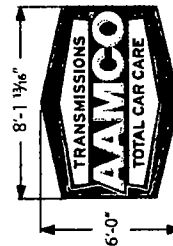

PROPOSED SIGNAGE

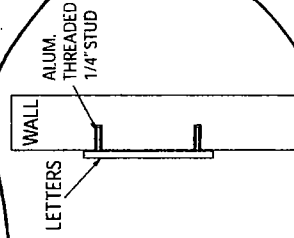
