ORDINANCE BOARD OF TRUSTEES UNIVERSITY OF ILLINOIS Acct. No. 309115 - 8

Permit No. 1131290

Be It Ordained by the City Council of the City of Chicago.

SECTION 1. Permission and authority are hereby given and granted to BOARD OF TRUSTEES UNIVERSITY OF ILLINOIS, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Pipe(s) under the public right-of-way adjacent to its premises known as 1250 S. Halsted St...

Said Pipe(s) at S Halsted Street (Hot Water Piping) measure(s):

Two (2) at sixty-six (66) feet in length, and two point five (2.5) feet in width for a total of three hundred thirty (330) square feet. Said pipes shall be approximately fifteen (15) feet below grade level.

Said Pipe(s) at S. Halsted Street (Chill Water Piping) measure(s):

Two (2) at sixty-six (66) feet in length, and two (2) feet in width for a total of two hundred sixty-four (264) square feet. Said pipes shall be approximately twenty (20) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1131290 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
