Said Fence(s) at S Avenue O Street measure(s): One (1) at eighteen (18) feet in length, and one (1) foot in width for a total of eighteen (18) square feet Existing fencing is approximately six (6) feet in height.

Said Fence(s) at Public Alley Between Avenue O Street & Avenue N Street measure(s): One (1) at fourteen (14) feet in length, and one (1) foot in width for a total of fourteen (14) square feet. Existing fencing is approximately six (6) feet in height

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1134567 herein granted the sum of eight hundred (\$800 00) per annum in advance.
