ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map 9-G in the area bounded by:

West Patterson Avenue; a line 131.19 feet west of the intersection of West Patterson Avenue and the 16' public alley perpendicular to West Patterson Avenue and next west of Clark Street, and the 16 foot wide public alley parallel to and next north of West Patterson Avenue

to those of RM-5 Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication

NARRATIVE ZONING ANALYSIS TYPE 1 ZONING MAP AMENDMENT APPLICATION

Applicant: Patterson Green LLC

Lot Area: 11,906 square feet

Patterson Green LLC is the "Applicant" for a Type 1 Zoning Map Amendment for the subject property located at 1118-24 West Patterson, Chicago, Illinois from the RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District to the RM-5 Residential Multi-Unit District in order to construct a four-story multi-unit residential building containing 18 residential dwelling units and 20 vehicular parking spaces.

The site is bounded by a 16' wide public alley to the north and east, Patterson to the south, and residential properties to the west.

The subject property consists of approximately 11,906 square feet of site area and is currently occupied by an existing 3-story multi-unit residential building, an existing two-story residential building, and a single story rear detached garage structure. The Applicant proposes to demolish the existing structures and erect a four-story multi-unit residential building containing 18 dwelling units. The ground floor will be occupied by an enclosed parking area and a building lobby. The overall project FAR will be 2.

A total of 20 vehicular parking spaces and 10 bicycle spaces will be provided on-site.




