ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RT4 Residential Two-Flat and Multi-Unit District and B3-2 Community Shopping District symbols and indications as shown on Map No.9-G in the area bounded by

the north right-of-way line of the second alley next north of and parallel to West Grace Street; the alley next northeast of North Clark Street; a line 375 feet northwest of the intersection of West Grace Street and North Clark Street as measured at the northeasterly right-of-way of North Clark and perpendicular thereto; and North Clark Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage And due publication.

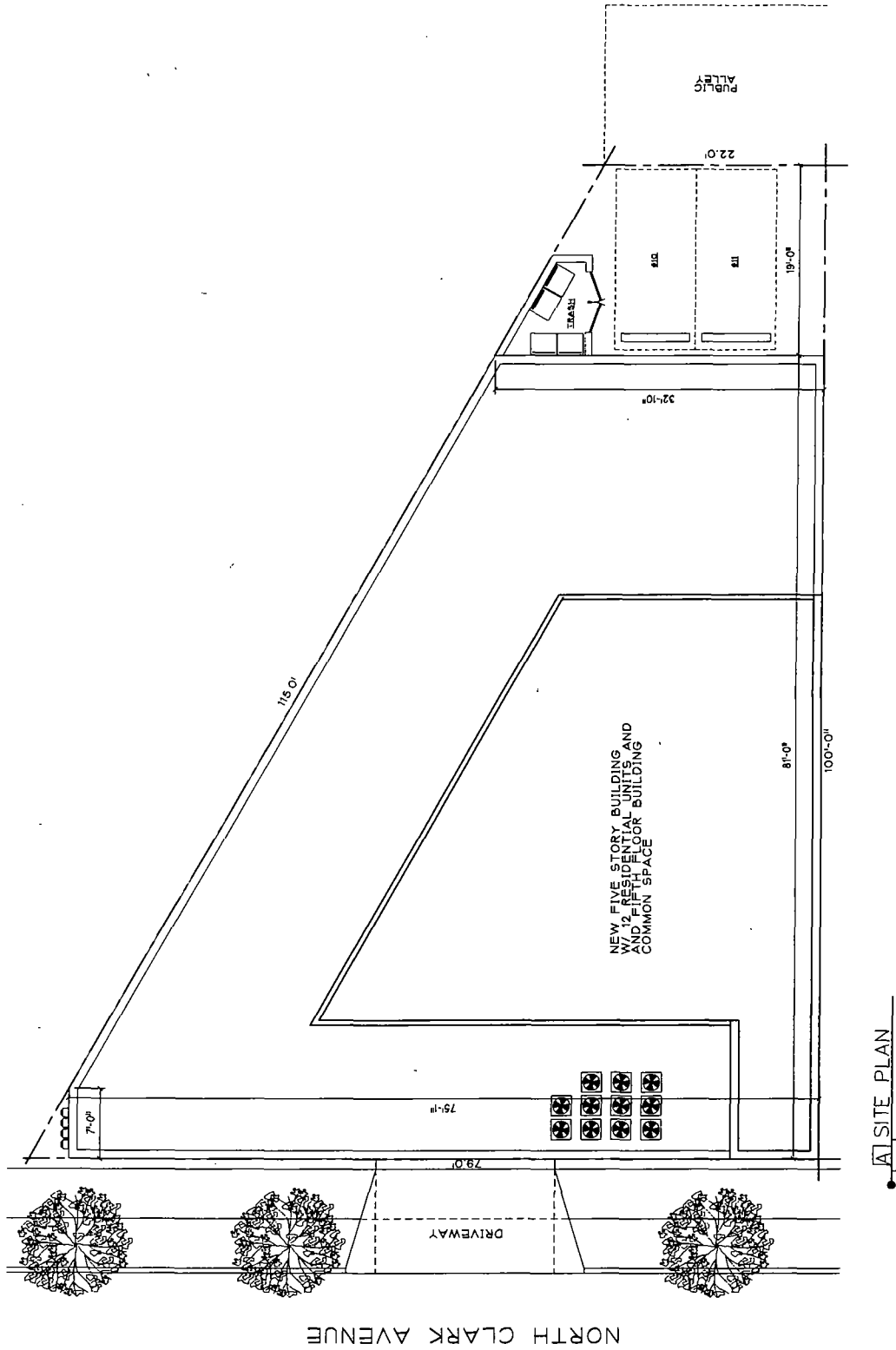

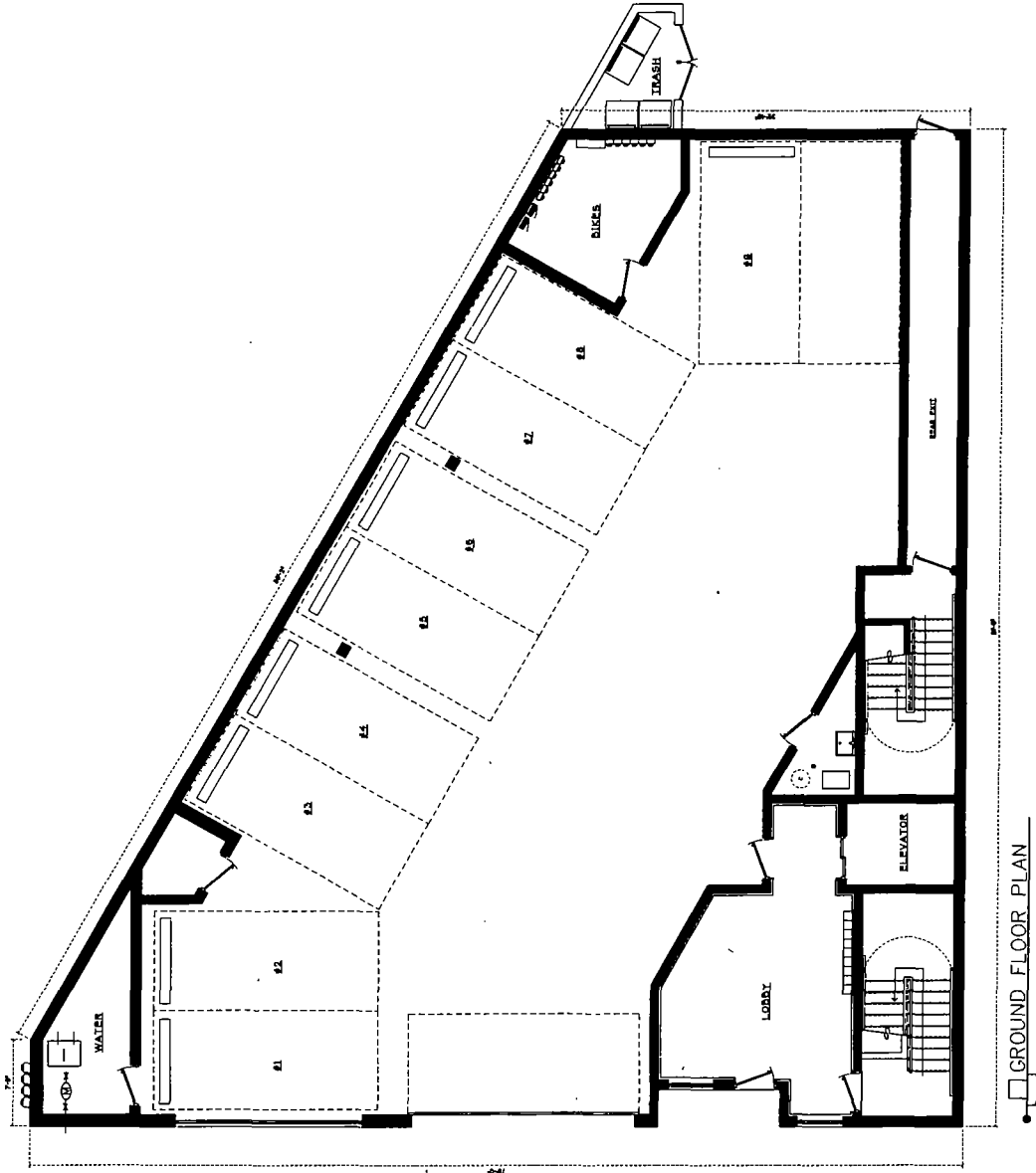

Proposed Land Use: The Applicant is seeking a zoning change in order to permit the construction of a new five-story all residential building, at the site. The proposed new building will contain a residential lobby and parking garage – at grade level, and twelve (12) dwelling units - above (Floors 2 thru 4). There will be an amenity room (i.e. ‘gym’), for the exclusive use of the residents of the new building – on the 5th Floor. The new proposed building will be masonry and glass in construction and measure 55 feet–4 inches in height. Due to its close proximity to the CTA Elevated Train Station, the Applicant is proposing to permit the proposal pursuant to the Transit Oriented Development (TOD) Ordinance. 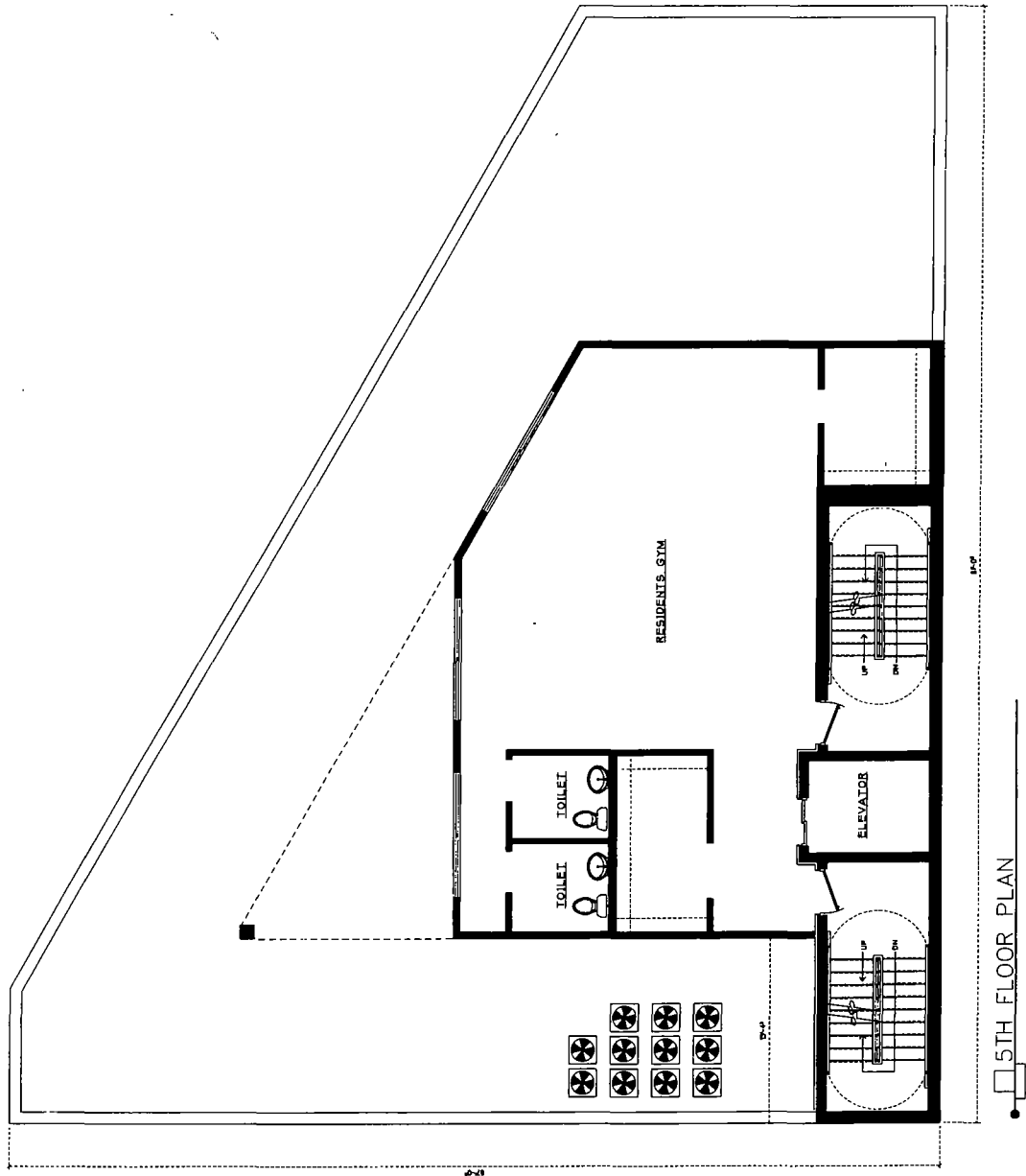


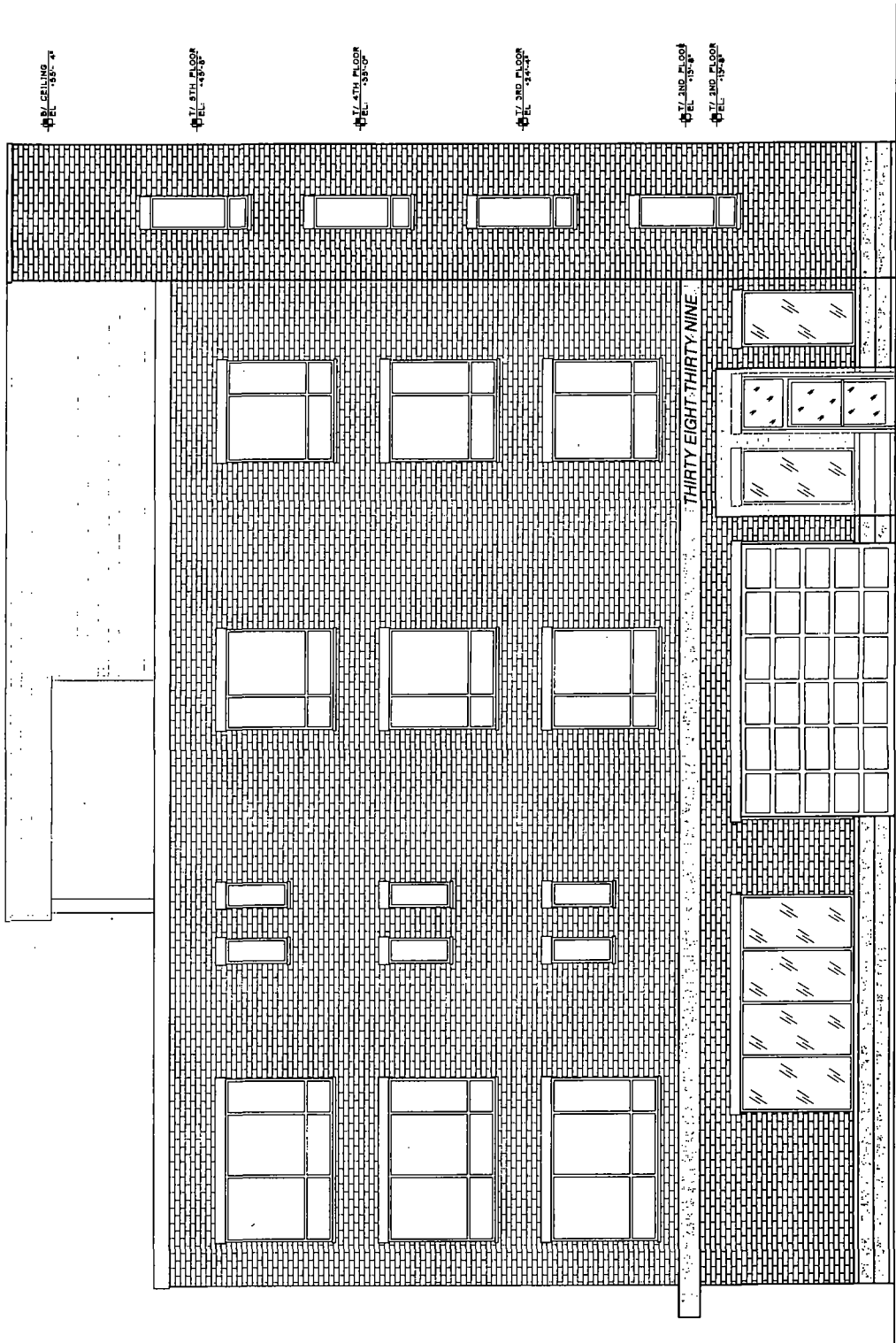
A SITE PLAN



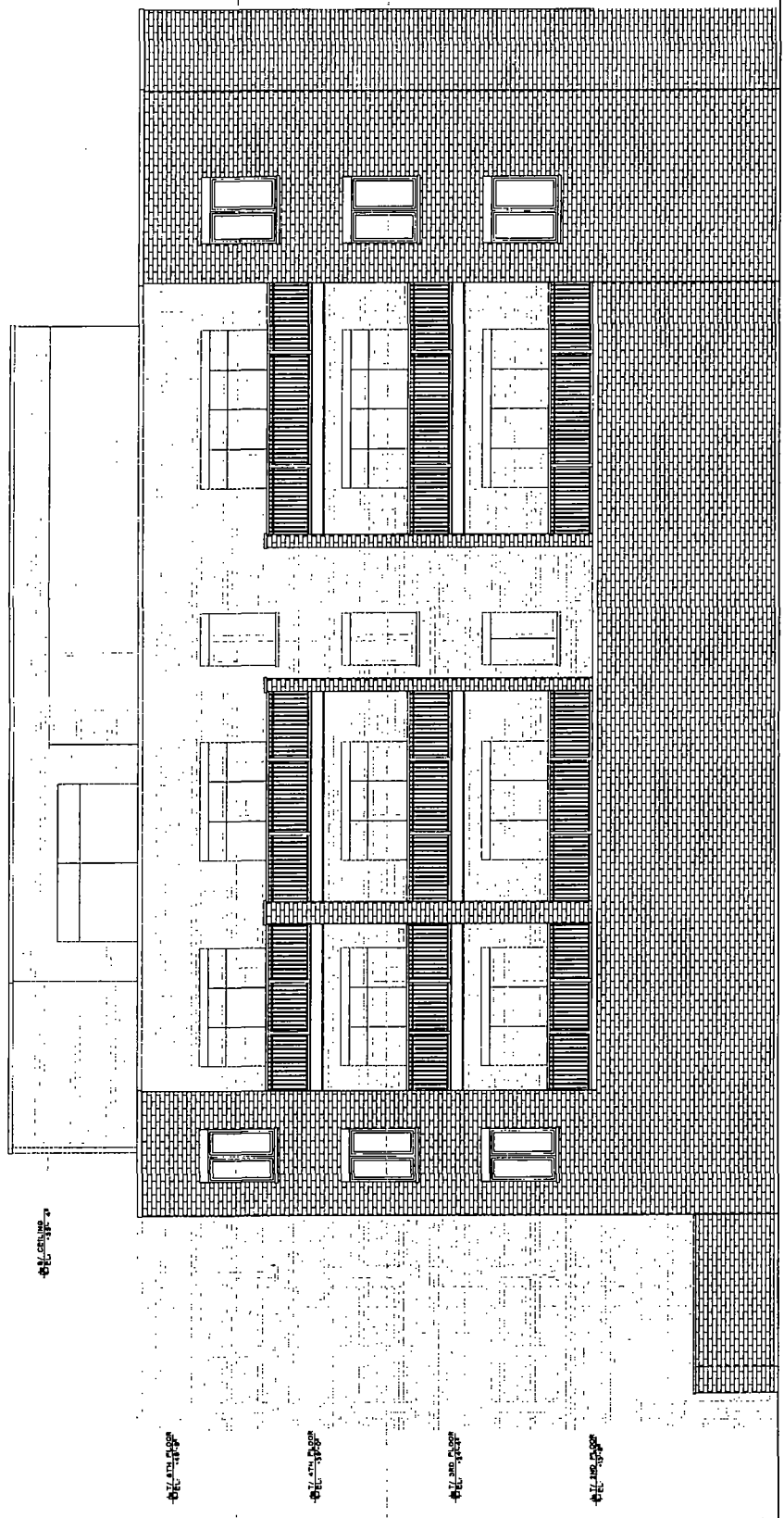


2ND, 3RD, 4TH FLOOR PLAN

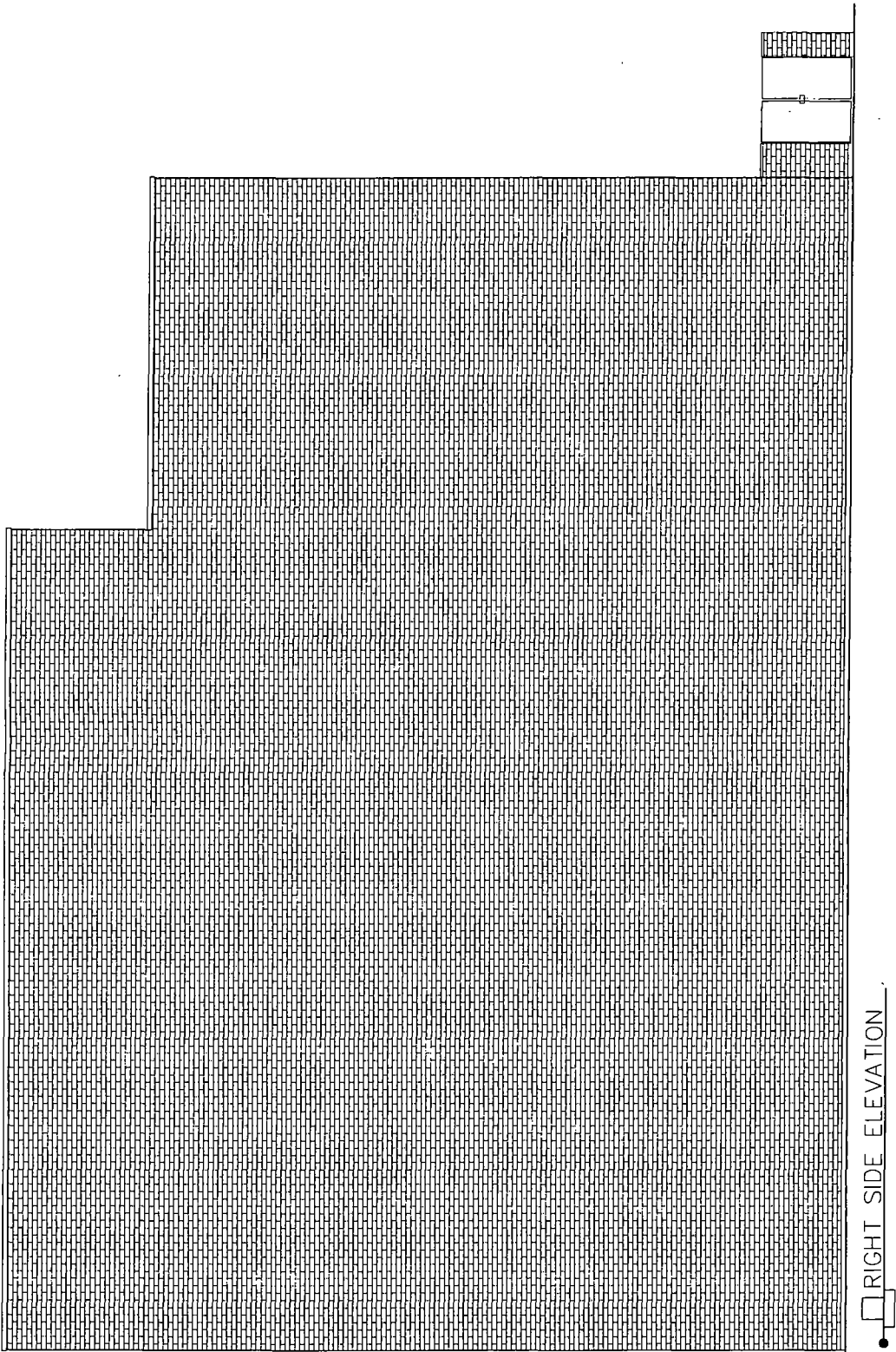
