#### BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indicators as shown on Map No. 7-N in the area bounded by

A line 200 feet southeast of North Harlem Avenue as measured along the north line of West Grand Avenue and perpendicular thereto; the public alley next north of and parallel to West Grand Avenue; a line 225 feet southeast of North Harlem Avenue as measured along the north line of West Grand Avenue and perpendicular thereto; and West Grand Avenue

to those of a C1-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about September 13, 2018, the undersigned will file an application for a change in zoning from B1-2 Neighborhood Shopping District to C1-2 Neighborhood Commercial District on behalf of Dream City Tattoos, LLC for the property located at 7172 West Grand Avenue, Chicago, IL 60707.

The applicant seeks this change so that it can obtain all Chicago Business Licenses to operate a tattoo parlor with piercing services in the leased ground-level storefront commercial space. Such uses are not allowed under the current B1-2 zoning but will be allowed under C1-2 zoning. The applicant currently operates a tattoo parlor with piercing services about a block away at 2376 North Neva Avenue and will be moving to this new location once it obtains the necessary licenses. 


