The alley next north of and parallel to West Diversey Avenue; North Ridgeway Avenue; West Diversey Avenue; a line 29.00 feet west of and parallel to North Ridgeway Avenue

to those of RM-5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

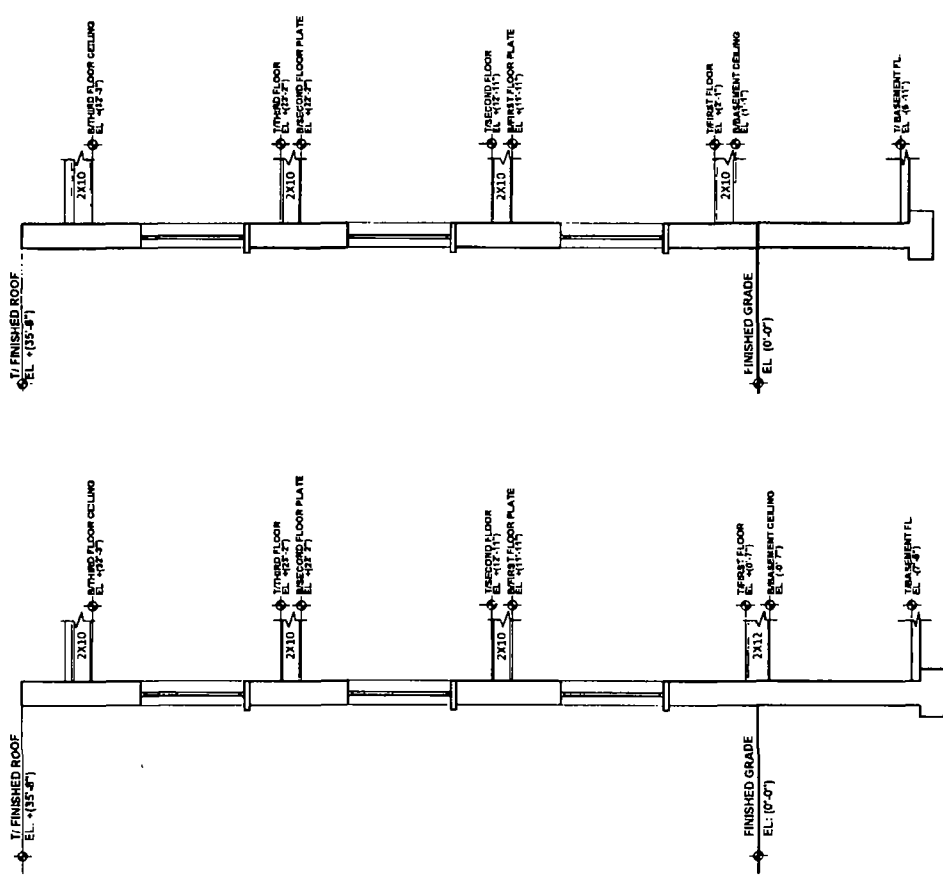
