ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the C2-2Motor Vehicle-Related Commercial District symbols and indications as shown on Map No.3-H in the area bounded by

a line 143.28 feet south of and parallel to West Hirsch Street;
the alley next east of and parallel to North Western Avenue;
a line 167.28 feet south of and parallel to West Hirsch Street;
and North Western Avenue,

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

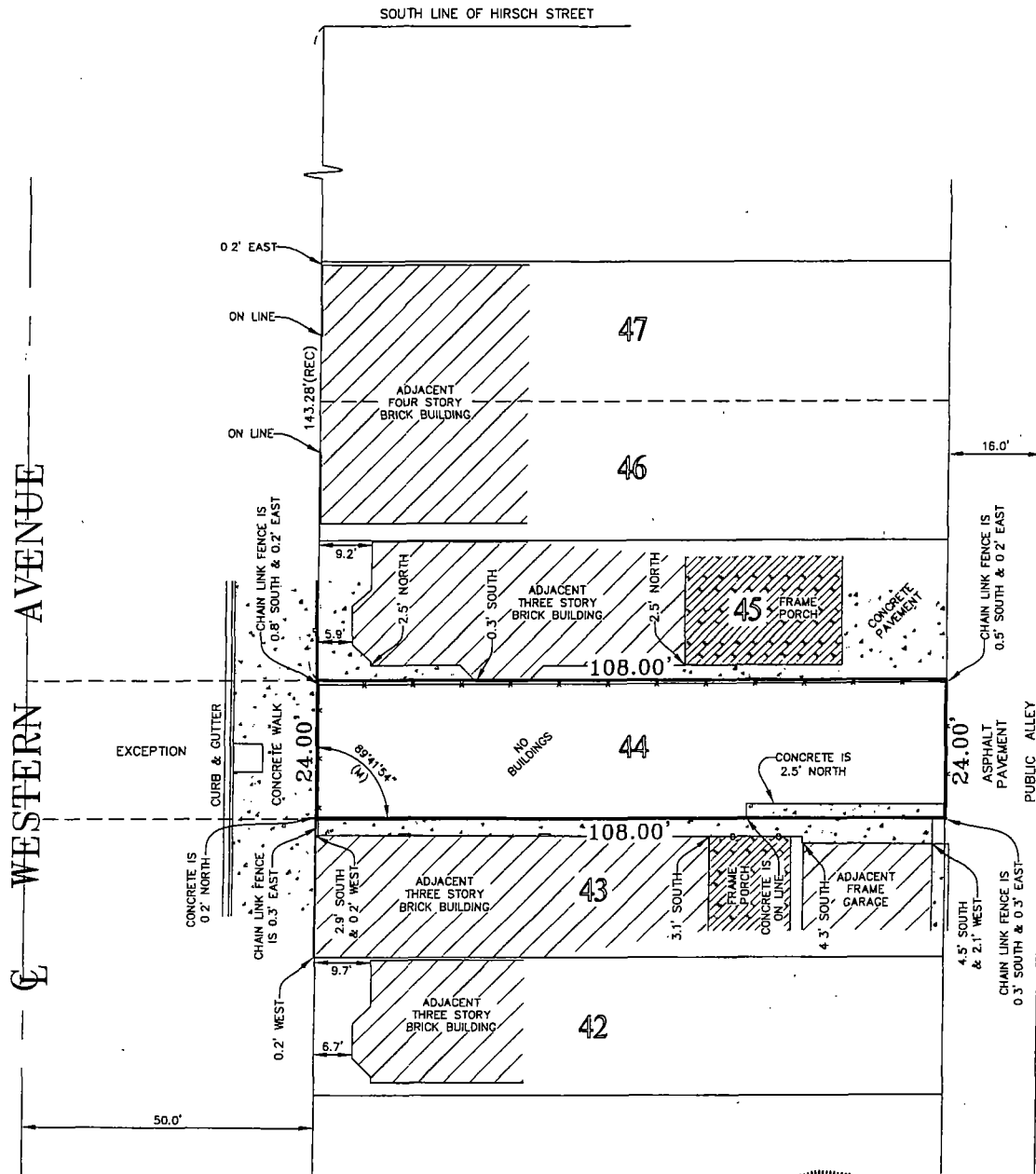
SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

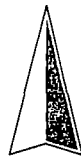
