ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 6-F in an area bound by

A line 400 feet East of and parallel to South Princeton Avenue, West 22nd Place, a line 425 feet East of and parallel to South Princeton Avenue, the public alley next South of and parallel to West 22nd Place

to those of a B2-3 Neighborhood Mixed-Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.


