## <u>O R D I N A N C E</u>

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the C1-2 Neighborhood Commercial District

symbols and indications as shown on Map No.5-I in the area bounded by

a line 162.74 feet north of and parallel to West Wabansia Avenue; North Western Avenue; West Wabansia Avenue; and the alley next west of and parallel to North Western Avenue,

to those of a B3-5 Community Shopping District and a corresponding uses district is

hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.
