

**RESOLUTION**  
**CLASS 6(B) REAL ESTATE TAX INCENTIVE FOR THE BENEFIT OF**  
**VCOR 47TH LLC, AN ILLINOIS LIMITED LIABILITY COMPANY,**  
**AND REAL ESTATE LOCATED GENERALLY AT**  
**4340 WEST 47TH STREET, IN CHICAGO, ILLINOIS**  
**PURSUANT TO COOK COUNTY, ILLINOIS TAX INCENTIVE ORDINANCE,**  
**CLASSIFICATION SYSTEM FOR ASSESSMENT**

**WHEREAS**, the Cook County Board of Commissioners has enacted the Cook County Tax Incentive Ordinance, Classification System for Assessment, as amended from time to time (the "County Ordinance"), which provides for, among other things, real estate tax incentives to property owners who build, rehabilitate, enhance and occupy property which is located within Cook County, Illinois and which is used primarily for industrial purposes; and

**WHEREAS**, the City of Chicago (the "City"), consistent with the County Ordinance, wishes to induce industry to locate and expand in the City by supporting financial incentives in the form of property tax relief; and

**WHEREAS**, VCOR 47th LLC, an Illinois limited liability company (the "Applicant"), purchased certain real estate located generally at 4340 West 47th Street, Chicago, Illinois 60632, as further described on Exhibit A hereto (the "Subject Property"), which contained an approximately 60,900 square foot industrial building, that had been totally vacant for more than two years prior to the purchase date, and substantially rehabilitated the building; and

**WHEREAS**, the Applicant has leased the entire Subject Property to Chicago Ornamental Iron, Inc., an Illinois corporation, to operate a metal fabricating business which manufactures, fabricates and installs custom designed architectural and structural metal work; and

**WHEREAS**, the redevelopment objective of the City in connection with the Subject Property is to support the City's goal of encouraging retention of the Applicant's operations within the City, creating new jobs and attracting investment; and

**WHEREAS**, the Subject Property is located within (i) the City of Chicago Enterprise Zone No. 2, created pursuant to the Illinois Enterprise Zone Act, 20 ILCS 665/1 et seq., as amended, and (ii) the Stevenson/Brighton TIF Redevelopment Project Area (created pursuant to the Illinois Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et. seq., as amended, and pursuant to an ordinance enacted by the City Council of the City), and pursuant to an ordinance enacted by the City Council of the City, as amended, and the purposes of Enterprise Zones and Redevelopment Areas are also to provide certain incentives in order to stimulate economic activity and to revitalize depressed areas; and

**WHEREAS**, it is the responsibility of the Assessor to determine that an application for a Class 6(b) classification or renewal of a Class 6(b) classification is eligible pursuant to the County Ordinance; and

**WHEREAS**, the County Ordinance requires that, in connection with the filing of a Class 6(b) eligibility application with the Assessor, the applicant must obtain from the municipality in which such real estate that is proposed for Class 6(b) designation is located a resolution

expressly stating, among other things, that the municipality has determined that the incentive provided by Class 6(b) is necessary for development to occur on such real estate and that the municipality supports and consents to the Class 6(b) classification by the Assessor; and

**WHEREAS**, the intended use of the Subject Property will provide significant present and future employment; and

**WHEREAS**, notwithstanding the Class 6(b) status of the Subject Property, the redevelopment and utilization thereof will generate significant new revenues to the City in the form of additional real estate taxes and other tax revenues; now, therefore,

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**


**SECTION 1:** That the City determines that the incentive provided by Class 6(b) is necessary for the development to occur on the Subject Property.

**SECTION 2:** That the City supports and consents to the Class 6(b) classification by the Assessor with respect to the Subject Property.

**SECTION 3:** That the Economic Disclosure Statement, as defined in the County Ordinance, has been received and filed by the City.

**SECTION 4:** That the Clerk of the City of Chicago is authorized to and shall send a certified copy of this resolution to the Assessor, and a certified copy of this resolution may be included with the Class 6(b) eligibility application filed with the Assessor by the Applicant, as applicant, in accordance with the County Ordinance.

**SECTION 5:** That this resolution shall be effective immediately upon its passage and approval.




