## ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Residential) District symbols and indications as shown on Map No. 1-H in the area bounded by

West Race Avenue; a line 120 feet east of and parallel to North Damen Avenue; the alley next south of and parallel to West Race Avenue; and a line 96 feet east of and parallel to North Damen Avenue,

to those of a RM4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.


